To-day is fixed for appearance of all the accused persons and E/R of warrant of arrest against the accused person namely Santosh Mahata and further order.

Out of Seventeen accused persons, fifteen accused persons namely Dilip Kumar Mahata, Badal Mahata, Chandra Sekhar Mahata, Mrinal Kanti Mahata, Bhudeb Mahata, Bidyut Singha, Arun Mahata, Ashok Mahata, Chittaranjan Samanta, Lakshiram Hembramon, Bajinath Tudu, Sundar Mandi, Jayram Bera @ Jay Bera @ Jaydeb Bera, Sasadhar Dolui, and Raju Adak on C.B. are present in Court by filing haziras.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

The accused persons namely Chhatradhar Mahata on C.B. is found absent.

Ld. Advocate for accused person namely Chhatradhar Mahata by filing a petition along with photocopies of medical papers stated that this accused person is unable to appear before this Court on the ground that he is suffering from viral fever and therefore Ld. Counsel prays for condoning his absence with a further prayer for adjournment today.

Having heard the submissions of the both sides, the prayers for condoning his absence is considered and allowed with a direction upon the accused person namely Chhatradhar Mahata to remain present before this Court on the next date fixed positively i.d. necessary order.

Abhijit Bala, Inspector, CIO, NIA, Kolkata files a compliance report through Ld. Special P.P, NIA in view of the order dated 23.09.2024. It appears from the report so filed today that NIA team made several attempts to arrest the said accused namely Santosh Mahata and found that he is in bed ridden condition in his own house since July, 2024 due to severe ill health from Vertigo and HTN. The report further reveals that if the accused Santosh Mahata is arrested in his serious ill health condition and transported from Lalgur to Kolkata, it may involve high risk to his life.

Ld. Special P.P, NIA submits before this Court that in the present circumstances, W/A in the name of Santosh Mahta may kindly be extended till next date for the ends of justice.

Heard Ld. Special P.P. of NIA.

Perused the case report and considered the submission made by the Ld. Special P.P, NIA.

Accordingly, let the Warrant of Arrest against the accused person namely Santosh Mahata be reissued with extension of time.

No report regarding proceedings u/s 446 of Cr. P.C against the sureties in respect of the accused, Santosh Mahata is received from Ld. Additional Chief Judicial Magistrate, 2nd Court, Jhargram as yet.

Ld. Additional Chief Judicial Magistrate, 2nd Court, Jhargram is hereby further directed to submit a report regarding proceedings u/s 446 of the Cr. P.C. against the sureties who stood as sureties on behalf of the accused person namely Santosh Mahata.

On submission of both sides, fix **21.01.2025** for appearance of all the accused persons and E/R of warrant of arrest against the accused person namely Santosh Mahata and submission of report regarding u/s 446 of Cr. P. C.

All the accused persons are directed to remain present on the next date fixed.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. of NIA for information and necessary action.
