To-day is fixed for appearance of all the accused persons and E/R of warrant of arrest against the accused person namely Santosh Mahata and submission of report regarding u/s 446 of Cr. P. C.

Out of Seventeen accused persons, twelve accused persons namely Dilip Kumar Mahata, Badal Mahata, Chandra Sekhar Mahata, Bhudeb Mahata, Arun Mahata, Chittaranjan Samanta, Lakkhiram Hembramon, Bajinath Tudu, Sundar Mandi, Sasadhar Dolui, Chhatradhar Mahata and Raju Adak on Court Bail are present in Court by filing hazira.

Ld. Counsels for these accused persons and the Ld. Special P. P. of NIA are present.

Four accused persons namely Mrinal Kanti Mahata, Bidyut Singha, Ashok Mahata and Jayram Bera @ Jay Bera @ Jaydeb Bera on Court Bail are found absent on calls.

Ld. Advocate for accused persons namely Mrinal Kanti Mahata, Bidyut Singha, Ashok Mahata and Jayram Bera @ Jay Bera @ Jaydeb Bera by filing a petition stated that these accused persons could not appear before this Court today and therefore Ld. Counsel prays for condoning their absence with a further prayer for an adjournment today.

Having heard the submissions of the both sides, the prayer for condoning their absence is considered and allowed with a direction upon the above named four accused persons to remain present before this Court on the next date fixed positively i.d. necessary order.

The CIO, NIA, Kolkata files a compliance report along with an unexecuted original warrant of arrest against the accused person namely Santosh Mahata through Ld. Special P.P, NIA stating that the concerned Authority visited the residence of accused person namely Santosh Mahata on 26.09.2024 to execute the arrest warrant, but the said warrantee could not be arrested due to his ill health (Vertigo and HTN) and it was not possible to transport him from Lalgarh to Kolkata by vehicle and other transportation and therefore the Ld. Special P.P. prays for extension of time for execution of warrant of arrest against the accused person namely Santosh Mahata.

Ld. Special P.P, NIA submits before this Court that in the present circumstances, W/A in the name of Santosh Mahta may kindly be extended till next date for the ends of justice.

Heard Ld. Special P.P. of NIA.

Perused the report and considered the submissions made by the Ld. Special P.P, NIA.

Accordingly, let the Warrant of Arrest against the accused person namely Santosh Mahata be reissued after extension of time for execution.

Received one report from the Court of Ld. Additional Chief Judicial Magistrate, Jhargram vide letter no.05 dated 07.01.2025 stating that in compliance with the order dated 27.11.2025 passed by this Court the proceedings u/s 446 of Cr. P.C were initiated against the sureties and thereafter the proceedings u/s 446 of Cr. P.C were completed and the fine imposed upon the sureties was duly paid and accordingly the said case with regard to proceedings u/s 446 of Cr. P.C. was disposed of on 05.12.2024.

Perused the same and let the same be kept with the record.

On submission of both sides, fix **25.02.2025** for appearance of all the accused persons and E/R of warrant of arrest against the accused person namely Santosh Mahata.

All the accused persons are directed to remain present on the next date fixed.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. of NIA for information and necessary action.
