To-day is fixed for appearance of all the accused persons and production of the accused person namely Santosh Mahata before this Court from J.C. in terms of order no.41 dated 20.02.2025 passed by this Court.

The accused person namely Santosh Mahata is produced before this Court from the J.C. in virtual mode.

Ld. Counsel appointed from the LADCS, Kolkata for the accused person namely Santosh Mahata is present by filing hazira along with an assignment letter bearing no.948/LADCS-KOL/2025 dated 24.02.2025.

Perused the same and let the same be kept with the record.

The accused person is identified by the concerned Jail Authority and he expressed before this Court that he could see and hear the entire court proceedings without any technical glitch.

Fifteen accused persons namely Dilip Kumar Mahata, Badal Mahata, Chandra Sekhar Mahata, Bhudeb Mahata, Arun Mahata, Chittaranjan Samanta, Lakkhiram Hembramon, Bajinath Tudu, Sundar Mandi, Sasadhar Dolui, Chhatradhar Mahata, Raju Adak, Bidyut Singha, Ashok Mahata and Jayram Bera @ Jay Bera @ Jaydeb Bera on Court Bail are present in Court by filing haziras.

The accused person namely Mrinal Kanti Mahata on Court Bail is found absent on calls.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

Ld. Advocate for accused person namely Mrinal Kanti Mahata by filing a petition along with photocopies of medical papers stated that the accused person could not appear before this Court today due to his illness and therefore Ld. Counsel prays for condoning his absence with a further prayer for an adjournment today.

Having heard the submissions of the both sides, the prayer for condoning the absence of the accused person namely Mrinal Kanti Mahata is considered and allowed with a direction upon the above named accused person to remain present before this Court on the next date fixed positively i.d. necessary order.

Received one medical report in respect of the accused person namely Santosh Mahata along with a forwarding letter bearing no.2805/IMB dated 24.02.2025 from the Superintendent of Presidency Correctional Home in terms of order no.41 dated 20.02.2025 passed by this Court.

Perused the same and let the same be kept with the record.

In view of the above report, the Superintendent of Presidency Correctional Home is again directed to take necessary steps for providing continuous medical treatment to the accused person namely Santosh Mahata strictly as per advice of the registered medical practitioner of the Correctional Home as per the provisions of West Bengal Correctional Services Act,1992.

Perused the case record.

On submission of all sides, fix **27.03.2025** for appearance of all the accused persons, production of the accused person namely Santosh Mahata and consideration of charge.

The accused person namely Santosh Mahata is remanded to J.C. till date.

All the accused persons are directed to remain present on the next date fixed positively.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary action.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. of NIA with a direction to remain present along with C.D. on the next date fixed positively.
