Today is fixed for further hearing of the bail application dated 28.02.2025 filed on behalf of the accused person namely Santosh Mahata together with the written objections dated 05.03.2025 and 10.03.2025 filed on behalf of the Prosecution/NIA.

Ld. Counsel appointed from the LADCS, Kolkata is present by filing hazira.

Ld. Special P.P. of NIA is present.

The I.O. is present along with the C.D.

A fresh Vakalatnama has been filed on behalf of the accused person namely Santosh Mahata.

Let the same be kept with the record.

As the accused person namely Santosh Mahata has already engaged his Ld. Counsel to defend and conduct the case on his behalf, the Ld. Counsel appointed from the LADCS, Kolkata is hereby released from conducting this case for this accused person.

The record is taken up for further hearing of the bail application dated 28.02.2025 filed on behalf of the accused person namely Santosh Mahata together with the written objections dated 05.03.2025 and 10.03.2025 filed on behalf of the Prosecution/NIA.

At this juncture, a petition has been filed on behalf of the accused person stating that the accused person namely Santosh Mahata is an aged person and is very sick and the accused person has been admitted to the Jail Hospital and therefore the Ld. Counsel for the accused person prays for a direction upon the concerned Correctional Home Authority to provide proper medical treatment to the accused person with a further prayer for an adjournment of the bail application dated 28.02.2025 filed on behalf of the accused person namely Santosh Mahata on the ground that the accused person is admitted to Jail Hospital and no instructions could be taken from the accused person prior to hearing of the bail application.

Heard the Ld. Counsel for the accused person namely Santosh Mahata.

In view of the prayer made in the petition, the Superintendent of Presidency Correctional Home is directed to take necessary steps for providing proper and adequate medical treatment to the accused person namely Santosh Mahata strictly as per advice of the registered medical practitioner of the Correctional Home as per the provisions of West Bengal Correctional Services Act,1992 and submit a detailed treatment report in this regard by the next date fixed.

Having heard the submissions of both sides, prayer for an adjournment is also considered and allowed.

Fix **25.03.2025** for further hearing of the bail application dated 28.02.2025 filed on behalf of the accused person namely Santosh Mahata together with the written objections dated 05.03.2025 and 10.03.2025 filed on behalf of the Prosecution/NIA.

To-date i.e. on **25.03.2025** for submissions of detailed medical report in respect of the accused person namely Santosh Mahata by the Superintendent of Presidency Correctional Home.

To-date i.e. on **27.03.2025** for appearance of all the accused persons, production of the accused person namely Santosh Mahata and consideration of charge.

Let a copy of this order along with a copy of the petition filed today on behalf of the accused person namely Santosh Mahata be sent to the Superintendent of Presidency Correctional Home for information and necessary action.

Let a copy of this order be sent to the LADCS, Kolkata for information.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. of NIA with a direction to remain present along with C.D. on the next date fixed positively.
