The accused persons namely Santosh Mahata, Badal Mahata, Chandra Sekhar Mahata, Lakkhiram Hembramon, Bajinath Tudu, Sundar Mandi, Sasadhar Dolui, Bhudeb Mahata, Bidyut Singha, Ashok Mahata, Arun Mahata, Dilip Kumar Mahata, Raju Adak, Jayram Bera @ Jay Bera @ Jaydeb Bera, Chhatradhar Mahata and Chittaranjan Samanta are absent by filing two petitions and have prayed for condoning their absence with a further prayer to allow the accused persons to be represented through their Ld. Counsels u/s 317 of the Cr. P.C.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

Heard both sides.

Prayer is considered and allowed with a direction upon these accused persons to remain present before this Court on the next date fixed positively.

The Ld. Counsels are at liberty to represent these accused persons u/s 317 of the Cr. P.C.

Inspector of Police, NIA, BO, Kolkata has filed a compliance report along with a Xerox copy of Death certificate bearing certificate no.D/2025/0349735 dated 02.07.2025 in the name of Mrinal Kanti Mahata issued by the Registrar (Birth and Death), Municipality Medinipur duly certified by Pradhan, Dharampur Gram Panchayat and statement of Susama Mahata through the Ld. Special P.P. of NIA in compliance with order no.56 dated 12.09.2025 passed by this Court stating that the accused person namely Mrinal Kanti Mahata expired on 28.06.2025.

Heard the Ld. Special P.P. of NIA.

Perused the compliance report, Xerox copy of Death certificate and statement of Susama Mahata.

In view of the above fact, the case against **the accused person namely Mrinal Kanti Mahata is filed for ever.**
