To-day is fixed for awaiting original G.R. case record from the Hon'ble Court, submission of report by the concerned Correctional Home and further hearing of the petition dated 27.09.2023 filed on behalf of the accused person regarding transfer of the accused from one Correctional Home to another Correctional Home together with the Prisoner's petition regarding transfer of the accused from one Correctional Home to another Correctional Home and production of the accused namely Hassan Imam @ Hesnu @ Zubair Ahmed @ Asif Hossain from the Correctional Home.

The accused person namely Hassan Imam @ Hesnu @ Zubair Ahmed @ Asif Hossain is not produced from J.C.

Received one report regarding non production of the UTP Hassan Imam @ Hesnu @ Zubair Ahmed @ Asif Hossain from the Superintendent of Hooghly Dist. Correctional Home communicated vide office letter no. 7908/AB dated 18.11.2023.

Perused the same and let the same be kept with the record

Received one compliance report along with one medical report in respect of the UTP Hassan Imam @ Hesnu @ Zubair Ahmed @ Asif Hossain from the Superintendent of Hooghly Dist. Correctional Home communicated vide office letter no. 4088/AB dated 17.11.2023 in terms of order no.75 dated 17.10.2023 passed by this Court.

Perused the same and let the same be kept with the record.

Ld. Advocate for the accused person is present.

It appears that the original G.R. case record has not yet been received from the Hon'ble Court.

The petition dated 27.09.2023 filed on behalf of the accused person regarding transfer of the accused from one Correctional Home to another Correctional Home is taken up for further hearing together with the Prisoner's petition regarding transfer of the accused from one Correctional Home to another correctional Home together with the report submitted by the Superintendent of Hooghly Dist. Correctional Home.

At this juncture, a petition has been filed on behalf of the Prosecution stating that Conducting Ld. P.P.-in-charge is unable to appear before this Court and therefore it is prayed for an adjournment on the ground stated therein.

Heard both sides on the point of adjournment.

Prayer for adjournment is considered and allowed.

The Superintendent of Hooghly Dist. Correctional Home is to ensure continuous medical treatment and diet of the accused person as per prescription of the Medical Officer and is also directed to take necessary steps to ensure production of the accused person namely Hassan Imam @ Hesnu @ Zubair Ahmed @ Asif Hossain before this Court on the date fixed.
