Received one report from A.S.I., Ganesh Rakshit of Shakespeare Sarani P.S. duly forwarded by the O/C, Shakespeare Sarani P.S. stating that a case vide Shakespeare Sarani P.S. Case no.19 dated 22.01.2002 u/s 120B/302/307/333/427 of IPC and section 25 (1B) (a)/27 of Arms Act was recorded by the Shakespeare Sarani P.S. and subsequently further investigation of the instant case was taken up by STF DD, Lalbazar under order of the superiors and so the original order sheet was sent to STF DD, Lalbazar on 25.09.2024 for compliance.

Perused the same and let the same be kept with the record.

Received one report from the Ld. Registrar, City Sessions Court, Calcutta stating that in compliance with the order no.87 dated 19.09.2024 passed by this Court a date was fixed on 25.09.2024 for opening of the said tin boxes upon due notice to all concerned and on the said date the inventory was adjourned to 04.10.2024 as per the prayer of the Prosecution and as such the inventory report could not be submitted before this Court today and therefore an accommodation has been sought for till 07.11.2024.

The accused person is remanded to J.C. till date.
