Order No.07 dated 13.05.2025

To-day is fixed for production of all the seven accused persons and examination of C.S.W. 26 and 27.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in virtual mode.

Ld. Counsels for the accused persons are present.

Ld. P. Ps.-in-charge are present by filing hazira.

The accused persons are identified by the concerned Jail Authority and they expressed before this Court that they could see and hear the entire court proceedings without any technical glitch.

C.S.W.26, Dr. Surajit Majumder is present before this Court. He is examined in chief as **P.W.2**, cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

The medical certificate of cause of death is proved and marked as **Exhibit P-4/P.W.2** (after objection).

C.S.W.27, Dr. Debashis Das is present before this Court. He is examined in chief as **P.W.3**, cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

The injury certificate of Irshad Alam dated 28.06.2024 is proved and marked as **Exhibit P-5/P.W.3**.

As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of P.W. nos.-2 and 3 dated 13.05.2025 are handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

A petition has been filed on behalf of the accused person namely 2) Pabitra Murmu praying for releasing the accused/petitioner on interim bail on the ground stated therein.

Copy served.

Let the same be kept with the record.

A petition along with annexures has been filed on behalf of the accused person namely 6) Dut Kr. Mondal praying for releasing the accused person on interim bail and/or directing the concerned Authority to send those two results of the accused/petitioner to the Superintendent of Presidency Correctional Home.

Copy served.

By filing this application accused has prayed for interim bail for collecting Eligibility Test Result Card 2024 of Patna Secondary Teacher, Eligibility Test, 2024.

Heard both sides.

Perused the record and annexure submitted with the application.

Ld. Public Prosecutor opposes the bail prayer.

I have carefully perused the record.

Considering the facts and circumstances of the case and the role played by the accused in the offence complained of, I do not find any just cause to allow the bail prayer of this accused person.

Accordingly the interim bail prayer of the accused person namely Dut Kumar Mondal stands **rejected**. However, the District Education Officer of Patna is directed to send result card of Dut Kumar Mondal in connection with Patna Secondary Teacher Eligibility Test, 2024 to the Superintendent of Presidency Correctional Home as early as possible.

Let a copy of this order be sent to the District Education Officer of Patna for information and necessary compliance.

Another petition has been filed on behalf of the accused persons praying for a direction upon the Superintendent of Presidency Correctional Home for production of the accused persons in physical mode on and from the next dated fixed.

Heard. Considered. Prayer is allowed.

The Superintendent of Presidency Correctional Home is directed to produce the accused persons in physical mode on the next date fixed positively.

Issue summons at once in the name of C.S.W. 1 namely Md. Imran Alam and C.S.W.2 namely Chotelal Shaw.

Requisites at once.

Fix **17.05.2025** for hearing of the bail application dated 13.05.2025 filed by the accused person namely 2) Pabitra Murmu.

Written objection, if any, in the meantime. Fix **10.06.2025** for production of all the seven accused persons and examination of C.S.Ws 1 and 2.

All the accused persons are remanded to J.C. till date.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home with a direction to take necessary steps to ensure production of the accused persons before this Court in physical mode.
