Order No.09 dated 10.06.2025

To-day is fixed for production of all the seven accused persons and examination of C.S.Ws. 1 and 2.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in physical mode.

Fresh Vakalatnama has been filed on behalf of the accused persons namely 4) Indrajit Handa and 6) Dut Kr. Mondal.

Ld. Counsels for the accused persons are present.

Ld. P. Ps.-in-charge are present by filing hazira.

**C.S.W.2, Chotelal Shaw** is present before this Court. He is examined in chief as **P.W.4**, cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

**C.S.W.1, Md. Imran Alam** is present before this Court. He is examined in chief as **P.W.5**, cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

Signature of P.W.5 on the statement is marked as **Exhibit P-6/P.W.5 (Collectively)**.

As per Gazette Notification dated 15.07.2022, the certified true copies of the depositions of P.W. nos.-4 and 5 dated 10.06.2025 are handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

A petition along with annexures has been filed on behalf of the accused person namely 2) Pabitra Murmu stating that the accused/petitioner is required to appear for the NET examination on 29.06.2025 to be held at the designated venue on scheduled time and therefore the accused/petitioner has prayed for a direction upon the Superintendent of Presidency Correctional Home to make necessary arrangement to enable the accused/petitioner to appear before the said examination on the schedule date and time.

A petition along with annexures has been filed on behalf of the accused person namely 5) Sekhar Mondal stating that the accused/petitioner is required to appear for the 4<sup>th</sup> Semester Examination on 24.06.2025, 26.06.2025 and 30.06.2025 and therefore the accused/petitioner has prayed for a direction upon the Superintendent of Presidency Correctional Home to make necessary arrangement to enable the accused/petitioner to appear before the said examination on the schedule dates and time.

Heard both sides.

The Superintendent of Presidency Correctional Home is directed to do the needful with regard to the prayer of the accused/petitioners namely Pabitra Murmu and Sekhar Mondal for their appearance in the ensuing examination on the schedule dates so fixed as per the Jail Code and as per the Provisions of Law and submits a report in this regard on the next date fixed.

Received one compliance report vide letter no.6239/WO dated 02.06.2025 in respect of the accused person namely Pabitra Murmu from the Superintendent of Presidency Correctional Home in terms of order no.08 dated 17.05.2025 passed by this Court.

Received one copy of intimation dated 20.05.2025 through Gmail from the Superintendent of Presidency Correctional Home.

Perused the same and let those be kept with the record.

Received one intimation from the Zila Karjakam Padadhikar, Stapna, Patna, (District Programme Officer, Establishment, Patna) vide no.2341 dated 05.06.2025.

Perused the same and let the same be kept with the record.

Ld. P.P. prays for issuance of summons upon the C.S.Ws.4 and 16

Accordingly, issue summons at once in the name of C.S.W. 4 and C.S.W.16.

Requisites at once.

Fixing **01.07.2025** for production of all the seven accused persons, submission of report by the Superintendent of Presidency Correctional Home and examination of C.S.Ws. 4 and 16.

All the accused persons are remanded to J.C. till date.
