The accused person namely 1) Sankar Barman is produced before this Court from the J.C. in virtual mode.

Received one report bearing no.7365/AB dated 01.07.2025 from the Superintendent of Presidency Correctional Home through office Email with regard to non production of the accused person namely Sankar Barman before this Court in physical mode.

Perused the same and let the same be kept with the record.

Ld. Counsels for the accused persons are present.

Ld. P. Ps.-in-charge are present by filing hazira.

C.S.W.4, Kaushik Barma is present before this Court. He is examined in chief as **P.W.6**, cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

Signature of P.W.6 on the statement under section 164 of the Cr. P.C. is marked as **Exhibit-P-7/P.W.6**.

C.S.W.16, Surojit Sardar is present before this Court. He is examined in chief as **P.W.7 in part**.

Signatures of P.W.7 on the statement are marked as **Exhibit P-8/P.W.7 (Collectively)**.

Further examination in chief of P.W.7 namely Surojit Sardar is deferred on the prayer of the Ld. P.P.-in-charge.

As per Gazette Notification dated 15.07.2022, the certified true copies of the depositions of P.W. nos.-6 and 7 dated 01.07.2025 are handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

Received one compliance report along with annexures in respect of the accused persons namely 2) Pabitra Murmu and 5) Sekhar Mondal from the Superintendent of Presidency Correctional Home vide letter no.7343/WO dated 30.06.2025 in terms of order no.09 dated 10.06.2025 passed by this Court.

Perused the same and let the same be kept with the record.

Fixing **15.07.2025** for production of all the seven accused persons, further examination of P.W.7 and examination of C.S.W.12.
