To-day is fixed for production of all the seven accused persons and examination of C.S.W. no.11 and C.S.W. no.13.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in physical mode.

Ld. Counsels for the accused persons are present.

Ld. P. Ps.-in-charge are present by filing hazira.

**C.S.W.11** namely **Shaktipada Biswas** is present in Court. He is examined in chief as **P.W.9** in full, cross-examined by the Ld. Counsels for all the accused persons **in full** and thereafter he is **discharged**.

The signatures of P.W.9 on the 1<sup>st</sup> seizure list dated 01.07.2024 in between 13:30 hrs to 14.035 hrs. are marked as **Exhibit-P-10/P.W.9 (collectively)** and the signatures of P.W.9 on the 2<sup>nd</sup> seizure list dated 01.07.2024 in between 16:30 hrs and 17:15 hrs are marked as **Exhibit-P-11/P.W.9 (collectively)**.

**C.S.W.13** namely **Nishit Kumar Halder** is present in Court. He is examined in chief as **P.W.10** in full, cross-examined by the Ld. Counsels for all the accused persons **in full** and thereafter he is **discharged**.

The signatures of P.W.10 on the seizure list dated 01.07.2024 in between 13:30 hrs to 14.035 hrs. are marked as **Exhibit-P-10/1/P.W.10** and **Exhibit-P-10/2/P.W.10**.

As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of P.Ws. no.9 and no.10 dated 05.08.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

Fixing **19.08.2025** for production of all the seven accused persons and examination of C.S.W. no.22 and C.S.W. no.32.

Fixing **28.08.2025** for production of all the seven accused persons and examination of C.S.W. no.20 and C.S.W. no.21.

Issue summons at once.

All the accused persons are remanded to J.C. till date.
