To-day is fixed for production of all the seven accused persons and examination of C.S.W. no.22 and C.S.W. no.32.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in physical mode.

One fresh Vakalatnama has been filed on behalf of the accused person namely Sankar Barman.

Let the same be kept with the record.

Ld. Counsels for the accused persons and the Ld. P. Ps.-in-charge are present.

C.S.W.32 namely **Gopal Mondal** is present in Court. He is examined in chief as **P.W.11** in **full** and cross-examined by the Ld. Counsel for the accused person nos.2 & 5 in **full** and thereafter cross-examined by the Ld. Counsel for the accused person nos.3, 4 & 6 **in part**.

The formal FIR is marked as **Exhibit-P-12/P.W.11**, the statement of Md. Imran is marked as **Exhibit-P-06/1/P.W.11 (collectively) (after objection)** and the original and certified copy of the General Diary Entry being Muchipara P.S. General Diary Entry no.2062 dated 28.06.2024 are simultaneously marked as **Exhibit-P-13/P.W.11** and the original and certified copy of the General Diary Entry being Muchipara P.S. General Diary Entry no.2099 dated 28.06.2024 are simultaneously marked as **Exhibit-P-14/P.W.11 (collectively)**.

Total four bats are marked as **Material Exhibit-P-I/P.W.11 (Collectively)**

Further cross examination of P.W.11 namely Gopal Mondal is deferred on the prayer of the Ld. Counsel for the accused person nos.3, 4 and 6.

As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of P.W. no.11 dated 19.08.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

C.S.W.22 namely Dilip Roy is released today without examination.

To-date i.e. on **28.08.2025** for production of all the seven accused persons, further cross-examination of P.W.11 namely Gopal Mondal and examination of C.S.W. no.22.

P.W.11 namely Gopal Mondal is directed to remain present before this Court on the next date fixed for adducing further evidence.

Re-issue the Summon in the name of C.S.W.22 namely Dilip Roy with a direction to remain present before this Court on the next date fixed for adducing evidence.

All the accused persons are remanded to J.C. till date.
