Order no. 16 dated 28.08.2025

1. Today is fixed for production of all the seven accused persons, further cross examination of PW-11 Gopal Mondal and examination of CSW-22.
2. All the seven accused persons are produced physically from the J/C.
3. Ld. Public Prosecutors and the Ld. Advocates representing the accused persons are present today.
4. Two SRs have been received from the concerned PS. Let those be kept with the record.
5. PW-11 Gopal Mondal is present today.
6. Now, the case record is taken up for recording evidence.
7. PW-11 Gopal Mondal is cross examined by the Ld. Advocate for the accused persons no.3, 4 & 6 in full and cross examined by the Ld. Advocate for the accused person no.1 in part.
8. At this juncture, the Ld. Advocate for the accused person no. 1 has prayed for deferring the cross examination of PW-11.
9. Heard. Considered. The prayer is allowed for ends of justice.
10. Hence, the cross examination in chief of PW-11 is deferred on prayer of the Ld. Advocate for the accused person no.1.
11. As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of PW-11 dated 28.08.2025 is handed over to all sides after obtaining endorsement in the relevant register.
12. Reissue summons upon the PW-11.
13. CSW-22 Dilip Roy is present today.
14. Accordingly, he is discharged today without examination.
15. Ld. Advocate for the accused person no.1 Sankar Barman has filed a petition u/s 311 of the Code of Criminal Procedure praying for allowing him for further cross examination of PW-1, PW-3, PW-5, PW-6 and PW-7.
16. Perused the petition. Let the same be kept with the record.
17. Ld. Advocates for the accused person nos. 6. Dut Kumar Mondal and 2. Pabitra Murmu have filed two separate petitions praying for passing necessary order to allow these accused persons to appear in the WBCSSC examination.
18. Now, the petitions are taken up for hearing.
19. The petitions are moved.
20. Ld. Advocates have prayed for passing necessary direction to allow these accused persons to appear in the WBCSSC examination.
21. Ld. Public Prosecutors leaves the matter to the discretion of this Court.
22. Heard. Perused the petitions and the photocopies of admit card of the accused persons of WBCSSC examination annexed with the petitions.

23. It appears that the accused Dutkumar Mondal is going to appear in the said examination which is scheduled to be held on 14.09.2025 and Pabitra Murmu is going to appear in the said examination which is scheduled to be held on 07.09.2025.
24. In view of above, the Superintendent, Presidency Correctional Home is directed to act within the ambit of Jail Code to make necessary arrangements with regard to the appearance of the accused persons, namely, Dutkumar Mondal and Pabitra Murmu, in WBCSSC examination after observing all the legal formalities.
25. Accordingly, both the petitions are disposed of.
26. Let a copy of this order be sent to the Superintendent, Presidency Correctional Home for information and necessary compliance.
27. Fixing **09.09.2025** for production of all seven accused persons, further cross examination of PW-11 Gopal Mondal, hearing of the petition u/s 311 of the Cr.P.C. filed by the accused Sankar Barman and written objection by the prosecution, if any, in the meantime.
28. All the accused persons are remanded to J/C till next date.
