The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in physical mode.

Ld. Counsels for the accused persons and the Ld. P. Ps.-in-charge are present.

P.W.11 namely **Gopal Mondal** is present in Court.

Ld. P.O. is on leave today.

I am heavily busy with my own file and so I could not take the matter for recording of evidence.

Accordingly, the case is adjourned today.

P.W.11 namely **Gopal Mondal** is released today without examination.

A petition along with a copy of Provisional Admit Card is filed on behalf of the accused person namely Pabitra Murmu praying for a direction upon the Superintendent of Presidency Correctional Home to make necessary arrangements for his appearance for the WBCSSC examination on the date mentioned in the petition.

Ld. Public Prosecutors leaves the matter to the discretion of this Court.

Heard. Perused the petition along with the photocopy of the admit card of the accused person of WBCSSC examination annexed with the petition.

It appears that the accused person namely Pabitra Murmu is going to appear in the said examination which is scheduled to be held on 14.09.2025.

In view of the above, the Superintendent of Presidency Correctional Home is directed to act within the ambit of Jail Code to make necessary arrangements with regard to the appearance of the accused person namely Pabitra Murmu in WBCSSC examination after observing all the legal formalities.

Accordingly, the petition is disposed of.
