To-day is fixed for production of all the seven accused persons, further examination of P.W.12, hearing of the petition u/s 311 of the Cr. P.C. dated 28.08.2025 and written objection, if any, in the meantime and hearing of the bail application dated 21.11.2025 filed on behalf of the accused person namely 7) Rana Hembram, written objection, if any, in the meantime.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in physical mode.

Ld. Counsels for the accused persons are present.

Ld. P. Ps.-in-charge are present.

P.W.-12 namely **Dilip Roy** is present in Court. He is further examined in **full**, cross-examined by the Ld. Counsel for the accused person nos.2 and 5 in full and cross-examined by the Ld. Counsel for the accused no.1 **in part**.

The signature of P.W.12 on the injury report issued on 28.06.2024 by the Medical College and Hospital, Kolkata is marked as **Exhibit-P-5/1/P.W.12**.

Further cross-examination of P.W.12 namely **Dilip Roy** is deferred on the prayer of the Ld. Counsel for the accused no.1.

As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of P.W. no.12 dated 28.11.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

Now, the bail application dated 21.11.2025 filed on behalf of the accused person namely 7) Rana Hembram is taken up for hearing.

At this juncture, a petition has been filed on behalf of the accused person namely 7) Rana Hembram praying for an adjournment with a further prayer for fixing a separate date on the next date fixed.

Heard both sides. Prayer for time is considered and allowed.

Fixing **05.12.2025** for hearing of the bail application dated 21.11.2025 filed on behalf of the accused person namely 7) Rana Hembram.

Fixing **15.12.2025** for production of all the seven accused persons, further cross-examination of P.W.12 and hearing of the petition u/s 311 of the Cr. P.C. dated 28.08.2025.

Re-issue the Summon in the name of P.W.12 with a direction to remain present before this Court on the next date fixed for adducing further evidence.

All the accused persons are remanded to J.C. till 15.12.2025.
