Order No.06 dated 05.10.2024

To-day is fixed for production of the accused persons, appointment of Ld. P.P. and for further order.

To-day is also fixed for hearing of the petition u/s 207 of the Cr. P.C. dated 03.09.2024 filed on behalf of the accused person namely 3) Pervesh Oraon.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C.

A fresh Vakalatnama has been filed on behalf of the accused person namely 1) Sankar Barman.

Let the same be kept with the record.

None turns up on behalf of the accused person 2) namely Pabitra Murmu.

No step is taken on behalf of the accused person 2) namely Pabitra Murmu.

Considering the above fact, the Ld. Chief Legal Aid Defence Counsel, Kolkata is directed to ensure appointment of one Ld. Lawyer to defend the case on behalf of the accused person 2) namely Pabitra Murmu.

Ld. Counsels for rest of the accused persons are present.

Ld. P. Ps.-in-charge are present by filing respective haziras along with a copy of appointment letter bearing memo no.8263-A/CS-02/2024 (Crl.) dated 27.09.2024 issued by the Ld. Legal Remembrancer, Govt. of West Bengal.

Let the same be kept with the record.

The petition u/s 207 of the Cr. P.C. dated 03.09.2024 filed on behalf of the accused person namely 3) Pervesh Oraon is taken up for hearing.

At this juncture, a petition has been filed on behalf of the accused person namely 3) Pervesh Oraon stating that petition u/s 207 of the Cr. P.C. dated 03.09.2024 has been found to be inappropriate and as such the Ld. Counsel is inclined to file a fresh application u/s 207 of the Cr. P.C. and therefore some time has been prayed for to file fresh application u/s 207 of the Cr. P.C.

Ld. Counsel for the accused person namely 3) Pervesh Oraon further submits that she is inclined to not press the petition u/s 207 of the Cr. P.C. dated 03.09.2024 filed on behalf of the accused person namely 3) Pervesh Oraon and subsequently she puts an endorsement on the petition u/s 207 of the Cr. P.C. dated 03.09.2024 with an endorsement "not pressed."

Accordingly, the petition u/s 207 of the Cr. P.C. dated 03.09.2024 filed on behalf of the accused person namely 3) Pervesh Oraon **stands rejected being not pressed.**

Heard both sides on the point of granting time to file fresh application u/s 207 of the Cr. P.C.

Prayer for time to file fresh application u/s 207 of the Cr. P.C. is considered and allowed.

Fix **13.11.2024** for production of the accused persons, filing fresh application u/s 207 of the Cr. P.C. on behalf of the accused person namely 3) Pervesh Oraon, if any, and consideration of charge.

All the accused persons are remanded to J.C. till date.

Let a copy of this order be sent to the Ld. Chief Legal Aid Defence Counsel, Kolkata for information and necessary action.
