Order no. 25 dated 09.01.2026

1. Today is slated for production of the accused persons, evidence of CSW-18 and hearing of the petition u/s 311 of Code of Criminal Procedure.
2. Accused persons, namely, Sankar Barman, Pabitra Murmu, Pervesh Oraon, Indrajit Handa, Sekhar Mondal, Dut Kr. Mondal and Rana Hembram, are produced before this Court from the J.C. in physical mode.
3. Ld. Public Prosecutor for the State and Ld. Advocates for the accused are present today.
4. CSW-18 Md Rasid Sarkar is present today.
5. Now, the record is taken up for recording evidence.
6. CSW-18 Md Rasid Sarkar is examined in chief as PW-13 by the Ld. Public Prosecutor in part.
7. Further examination of PW-13 is deferred on prayer of the Ld. Public Prosecutor on the ground of non-production of alamats.
8. During the course of examination, signatures of PW-13 on the seizure list dated 06.07.2024 are marked Exhibit P-15/1/PW-13 and Exhibit P-15/2/PW-13 respectively, signatures of PW-13 on the 1st seizure list dated 08.07.2024 is marked as Exhibit P-16/1/PW-13, signature of PW-13 on the 2nd seizure list dated 08.07.2024 is marked as Exhibit P-17/1/PW-13, signature of PW-13 on the 3rd seizure list dated 08.07.2024 is marked as Exhibit P-18/1/PW-13, signature of PW-13 on the 4th seizure list dated 08.07.2024 is marked as Exhibit P-19/1/PW-13, signature of PW-13 on the 5th seizure list dated 08.07.2024 is marked as Exhibit P-20/1/PW-13 and signature of PW-13 on the 6th seizure list dated 08.07.2024 is marked as Exhibit P-21/1/PW-13.
9. As per Gazette Notification dated 15.07.2022, certified true copies of the deposition of PW-13 dated 09.01.2026 are handed over to all sides after obtaining endorsement in the relevant register.
10. At this juncture, Ld. Advocates concertedly submit that the extract copies of seized mobiles have not been supplied yet to the accused persons. So, they pray for passing necessary direction upon the prosecution to supply the same to the accused persons.
11. Heard. Considered. The prayer is allowed.
12. The prosecution is directed to provide/supply the copy to the accused persons through the Email ID's of their Ld. Advocates or share the Google Drive link in the Email IDs, so that they can visit and get it digitally at their convenience by 19.01.2026 positively.
13. In this regard, the Ld. Advocates of the accused persons are directed to furnish their Email IDs before this court so that prosecution can able to supply/provide the copy in the Email IDs or share the Google Drive link.
14. Fix **22.01.2026** for production of the accused persons, further examination of PW-13 and hearing of the petition u/s 311 of Code of Criminal Procedure.

15. The accused be remanded to J/C till 22.01.2026.

16. Prosecution is directed to take proper steps to ensure the presence of PW-13 on the next date fixed.
