Order no. 26 dated 22.01.2026

1. Today is fixed for production of the accused persons, evidence of CSW-18 and hearing of the petition u/s 311 of Code of Criminal Procedure.
2. Accused persons, namely, Sankar Barman, Pabitra Murmu, Pervesh Oraon, Indrajit Handa, Sekhar Mondal, Dut Kr. Mondal and Rana Hembram, are produced before this Court from the J.C. in physically.
3. Ld. Public Prosecutor for the State and Ld. Advocates for the accused are present today.
4. PW-13 Md Rasid Sarkar is present before this Court.
5. Now, the record is taken up for recording evidence.
6. PW-13 is cross examined by the Ld. Advocates of the accused persons in full barring the Ld. Advocate for the accused Sekhar Mondal. Cross examination of PW-13 is declined by the Ld. Advocate for the accused Sekhar Mondal. Thereby, PW-13 is discharged.
7. During the course examination, the signature of PW-13 on the label pasted on an envelope is marked as Mat Exhibit P-II/1/PW-13, one mobile is marked as Mat Exhibit P-II/PW-13, the signature of PW-13 on the label pasted on an another envelope is marked as Mat Exhibit P-IV/1/PW-13, another mobile is marked as Mat Exhibit P-V/PW-13, the signature of PW-13 on the label pasted on an another envelope is marked as Mat Exhibit P-VI/1/PW-13, one small envelope and one pen drive are altogether marked as Mat Exhibit P-VII/PW-13, the signature of PW-13 on the label pasted on an another envelope is marked as Mat Exhibit P-VIII/1/PW-13 and another small envelope and one pen drive are altogether marked as Mat Exhibit P-IX/PW-13.
8. As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of PW-13 dated 22.01.2026 is handed over to all sides after obtaining endorsement in the relevant register.
9. Ld. Public Prosecutor prays for issuing summons upon CSW-19 for recording evidence.
10. Issue summons accordingly.
11. Fix **03.02.2026** for production of the accused persons, evidence of CSW-19 and hearing of the petition u/s 311 of Code of Criminal Procedure.
12. The accused persons be remanded to J/C till 03.02.2026.
