Order No.08 dated 13.11.2024

To-day is fixed for production of the accused persons, filing fresh application u/s 207 of the Cr. P.C. on behalf of the accused person namely 3) Pervesh Oraon, if any, and consideration of charge.

To-day is also fixed for submission of report by the I.O. of this case with regard to return of the seized mobile phone (Samsung A20) to the petitioner namely Manoj Sarkar.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C.

Ld. Counsel appointed from the LADCS, Kolkata the accused person namely 2) Pabitra Murmu is present by filing hazira along with a copy of Assignment bearing no.836/LADCS-KOL/2024 dated 08.10.2024.

Let the same be kept with the record.

A fresh Vakalatnama has been filed on behalf of the accused person namely 2) Pabitra Murmu.

As the accused person 2) namely Pabitra Murmu has already engaged Ld. Counsel to conduct this case on his behalf, the Ld. Counsel appointed from the LADCS, Kolkata is hereby released from conducting this Court.

Ld. Counsels for rest of the accused persons are present.

Ld. P. Ps.-in-charge are present by filing respective haziras.

A petition u/s 207/208 of the Cr. P.C. has been filed on behalf of the accused person namely 3) Pervesh Oraon praying for a direction upon the Prosecution to supply copies as mentioned in the petition dated 13.11.2024 along with all relied upon and non relied upon documents u/s 207/208 of the Cr. P.C. to the accused person on the ground stated therein.

Copy served as per the endorsement.

Let the same be kept with the record.

Two separate bail applications have been filed on behalf of the accused persons namely 1) Sankar Barman and 4) Indrajit Handa.

Copies served as per the endorsement.

Let those be kept with the record.

Ld. Counsels for the accused persons prayed for disposing of the three petitions filed today on behalf of the accused persons and thereafter to take up the hearing on the point of consideration of charge against the accused persons as some important documents have not been furnished by the Prosecution and the Court should not proceed

with the framing of charge without those documents being supplied to the accused persons.

Ld. P.P. in charge submits that he is ready for hearing on the point of consideration of charge and he vehemently raises objection and submits that the Prosecution is fully prepared to read out the charge in Court today and the I.O. and the case diary is also with him.

Ld. P.P. further submits that the Ld. Advocates for the accused persons are deliberately delaying the process of framing of charge to get advantage before the Hon'ble Court at the time of bail hearing.

This Court is of the view that the petition u/s 207/208 of the Cr. P.C. dated 13.11.2024 filed on behalf of the accused person namely 3) Pervesh Oraon and the two bail applications dated 13.11.2024 filed on behalf of the accused persons namely 1) Sankar Barman and 4) Indrajit Handa should be disposed of at the first instance and thereafter the record will be taken up for consideration of charge.

In view of such fact, the case is adjourned for the ends of justice.

No report with regard to return of the seized mobile phone (Samsung A20) to the petitioner namely Manoj Sarkar has yet been filed by the I.O. of this case in compliance with the order no.07 dated 08.10.2024 passed by this Court.

Accordingly, the I.O. is further directed to submit a report in this regard by the next date fixed positively.

Fix **26.11.2024** for production of the accused persons, hearing of application u/s 207/208 of the Cr. P.C. dated 13.11.2024 on behalf of the accused person namely 3) Pervesh Oraon, hearing of the two bail applications dated 13.11.2024 filed on behalf of the accused persons namely 1) Sankar Barman and 4) Indrajit Handa at the first instance and thereafter consideration of charge.

To-date i.e. on **26.11.2024** for submission of report by the I.O. of this case with regard to return of the seized mobile phone (Samsung A20) to the petitioner namely Manoj Sarkar

Written objections, if any, in the meantime.

All the accused persons are remanded to J.C. till date.

Let a copy of this order be sent to the Ld. Chief Legal Aid Defence Counsel, Kolkata for information and necessary action.

Let a copy of this order be sent to the I.O. of this case through concerned O/C with a direction to take necessary steps to ensure production of the C.D. on the next date fixed.
