Order No.09 dated 26.11.2024

To-day is fixed for production of the accused persons, hearing of application u/s 207/208 of the Cr. P.C. dated 13.11.2024 on behalf of the accused person namely 3) Pervesh Oraon, hearing of the two bail applications dated 13.11.2024 filed on behalf of the accused persons namely 1) Sankar Barman and 4) Indrajit Handa at the first instance and thereafter consideration of charge.

To-day is also fixed for submission of report by the I.O. of this case with regard to return of the seized mobile phone (Samsung A20) to the petitioner namely Manoj Sarkar.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C.

Ld. Counsels for all the accused persons are present.

Ld. P. Ps.-in-charge are present by filing respective haziras.

Ld. P.P submits that they have supplied all the relied upon and non relied upon documents to the accused no. 3) Pervesh Oraon u/s 207/208 of the Cr. P.C today.

One I.O's report regarding release of the seized articles to the complainant in terms of the order no. 07 dated: 08.10.2024 is filed before this court. Let the report be kept with the record.

Now the petition dated 08.10.2024 regarding the return of the seized mobile phone (Samsung A 20) to the petitioner namely, Manoj Sarkar is taken up for hearing along with the report so filed today.

None moves the petition. It is now 1:00 P.M.

This Court is inclined to give an opportunity to the petitioner to make his submissions and to be heard on the point of returning the seized articles on the next date fixed.

Now the petition u/s 207/208 of the Cr. P.C. filed on behalf of the accused person namely 3) Pervesh Oraon praying for a direction upon the Prosecution to supply copies as mentioned in the petition dated 13.11.2024 along with all relied upon and non relied upon documents in terms of section 207/208 of the Cr. P.C.is taken up for hearing.

At this stage, Ld. P.P submits before this Court that prosecution has supplied all relied upon and non relied upon documents u/s 207/208 of the Cr. P.C. to the accused person today.

Ld. Advocate for the accused person submits that he has received all documents as supplied by the prosecution today without verifying the contents of those documents and further submits that defence has not been supplied with the list of non relied upon

documents as per Gazette Notification Rule 91A and of the Calcutta High Court Criminal Rules and Order.

Heard.

Prosecution is hereby directed to supply the list of non relied upon documents to the accused no. 3) Pervesh Oraon in the meantime, if not supplied till date, in compliance with Rule 91A of the Criminal Rules and Orders as framed by the Hon'ble Court at Calcutta.

Ld. Advocate for the accused no. 6) Dut Kr. Mondal files a bail application along with annexures.

Copy served as per the endorsement "objected to".

Let the same be kept with the record.

Now the three bail applications filed on behalf of the three accused persons namely 1) Sankar Barman, 4) Indrajit Handa and 6) Dut Kumar Mondal are taken up for hearing together.

At this stage, Ld. Advocate for the accused persons files petitions and prays for time on the grounds that some more instructions are required and they are not ready today.

Ld. P.P. raised no objection regarding the prayer of adjournment as sought for by the defence side.

Heard both sides. Considered. The prayer for adjournment is allowed.

On submission of both sides, fix **02.12.2024** for production of the accused persons, hearing of the three bail applications two of which is dated 13.11.2024 and one bail is petition dated 26.11.2024 filed on behalf of the accused persons namely 1) Sankar Barman, 4) Indrajit Handa and 6) Dut Kumar Mondal at the first instance and thereafter consideration of charge.

To-date i.e. on **02.12.2024** for hearing of the petition dated 08.10.2024 with regard to return of the seized mobile phone (Samsung A20) to the petitioner namely Manoj Sarkar together with report so filed by the I.O.today.

Written objections against the bail petitions, if any, in the meantime.

All the accused persons are remanded to J.C. till date.

Let a copy of this order be sent to the I.O. of this case through concerned O/C with a direction to take necessary steps to ensure production of the C.D. on the next date fixed.
