To-day is fixed for production of all the seven accused persons and further examination in chief of P.W.1, Dr. Koushik Tudu.

The accused persons namely 1) Sankar Barman, 2) Pabitra Murmu, 3) Pervesh Oraon, 4) Indrajit Handa, 5) Sekhar Mondal, 6) Dut Kr. Mondal and 7) Rana Hembram are produced before this Court from the J.C. in virtual mode.

Received one report from the Superintendent of Presidency Correctional Home, Alipore, Kolkata-27 vide letter no.1875/AB dated 06.02.2025 with regard to production of the accused persons in virtual mode.

Let the same be kept with the record.

Ld. Counsels for all the accused persons are present.

Ld. P. Ps.-in-charge are present by filing respective haziras.

P.W.1, Dr. Koushik Tudu is present before this Court.

The accused persons are identified by the concerned Jail Authority and they expressed before this Court that they could see and hear the entire court proceedings without any technical glitch and the accused persons also gave consent to take up the matter for recording of evidence.

In presence of both sides the record is taken up for recording of evidence. **P.W.1, Dr. Koushik Tudu** is further examined in chief **in full** and thereafter he is cross-examined by the Ld. Counsel for the accused person no.5) namely Sekhar Mondal **in part**.

The final opinion dated 11.12.2024 prepared by the witness, P.W.1, Dr. Koushik Tudu is proved and marked as **Exhibit-P-3/P.W.1. (With objection by the Ld. Counsel for the accused no.7)**

Further cross-examination of P.W.1, Dr. Koushik Tudu is deferred on the prayer of the Ld. Counsel for the accused person no.5) namely Sekhar Mondal.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W-1 dated 07.02.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsel after obtaining endorsement in the relevant register.

Received one compliance report from the Superintendent Presidency Correctional Home, Calcutta vide letter no.1610/WO dated 01.02.2025 in terms of order no.02 dated 06.01.2025 passed by this Court in respect of the accused person namely Sekhar Mondal.

Perused the same and let the same be kept with the record.

Fix **05.03.2025** for production of all the seven accused persons and further cross-examination of P.W.1, Dr. Koushik Tudu.

Re-issue the summon in the name of P.W.1, Dr. Koushik Tudu at once with a direction to appear before this Court on the next date fixed positively for adducing evidence.

All the accused persons are remanded to J.C. till date.
