Order no. 19 dated 29.07.2026

Today is fixed for production of CCL, submission of report and passing order in respect of letter bearing no. 947/DLSAK/2023 dated 09.06.2026 received from the Secretary, DLSA, Kolkata.

CCL, namely, Sujit Kumar @ Bauwa is produced from the Dhurbashram, Observation and Special Home, Ariadaha, Kolkata.

Ld. Advocate for the CCL is present.

Ld. Public Prosecutor representing the State is present.

A report in compliance with the order dated 21.07.2026 has been received from the Superintendent of Dhurbashram, Observation and Special Home, Ariadaha, Kolkata. Let the same be kept with the record.

Now the record is taken up for passing order in respect of letter bearing no. 947/DLSAK/2023 dated 09.06.2026 received from the Secretary, DLSA, Kolkata.

Heard both sides.

Perused the case record.

For better appreciation, the Section 19 (3) of the Juvenile Justice (Care and Protection of Children) Act, 2016 is produced hereunder:

“(3) The Children's Court shall ensure that the child who is found to be in conflict with law is sent to a place of safety till he attains the age of twenty-one years and thereafter, the person shall be transferred to a jail”.

It appears from the report that since 18.09.2021, the CCL, Sujit Kumar @ Bauwa, has been staying at Dhurbashram, Observation and Special Home, Ariadaha, Kolkata, and has now attained the age of 21 years and accordingly, retaining him in the home is statutorily barred.

Considering the facts and circumstances, accused Sujit Kumar @ Bauwa be sent to J/C.

One petition has been filed on behalf of accused Sujit Kumar @ Bauwa stating that the accused seeks to pursue his career in cricket and for which he needs to undergo professional training and practice. So, he prayed for passing necessary order.

Heard. Considered.

The Superintendent of Presidency Correctional Home is directed to take necessary steps in this regard as per Jail Code.

Issue custody warrant.

Let a copy of this order along with a copy of the petition of accused Sujit Kumar @ Bauwa be sent to the Superintendent of Presidency Correctional Home for information.

Let a copy of this order be sent to the Superintendent, Dhurbashram, Observation and Special Home, Ariadaha, Kolkata for information.

Accused Sujit Kumar @ Bauwa is remanded to J/C till 24.08.2026.
