8. In view of the above fact, the Superintendent of Presidency Correctional Home is directed to take necessary steps to ensure production of the accused person namely Sumit Kumar Purkait physically before this Court on the next date fixed.

11. Fixing **07.04.2026** for production of the accused person namely Sumit Kumar Purkait, filing Vakalatnama on behalf of the accused person and appointment of Ld. Public Prosecutor.
12. The accused person namely Sumit Kumar Purkait is remanded to J.C. till 07.04.2026.
13. Let a copy of this order be again forwarded to the Ld. Chief Public Prosecutor, City Sessions Court, Calcutta for information.
14. Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary action.
