Today the Case record is fixed for appearance, production of the accused persons and for hearing of petition u/s. 294 Cr.P.C.

Accused Md. Afroz [A-2] and Shyamlal Sah [A-3] on C.B are present by filing their respective haziras.

One petition along with server copy of order dated 23.04.2025, passed by the Hon'ble High Court, Calcutta in C.R.M (D.B.) 798 of 2025 is filed on behalf of the accused Mukesh Thakur [A-1]. On perusal of the said order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased *“to grant bail to the accused Mukesh Thakur on conditions that (1). He will furnish bond of Rs. 10,000/- (rupees Ten Thousand only), with two sureties of like amount each, one of whom must be local to the satisfaction of the Learned Chief Judicial Magistrate, Calcutta (2) He shall remain within the Jurisdiction of Burrabazar P.S. and shall furnish the address where he presently resides and his mobile phone number before this Court, the Investigating Officer and the Officer -in-Charge of the Police Station concerned under whose jurisdiction he shall henceforth reside. He shall not change the said mobile phone number without intimation to this Court, the Investigating Officer and Officer-in-Charge of the concerned P.S and shall appear before this court on every date of hearing”*.

One letter bearing No. 2188 dated 08.05.2025 is received from the Ld. Chief Judicial Magistrate, Calcutta wherein, it appears that in compliance with the direction of the Hon'ble Court, bail bonds have been furnished on behalf of the accused Mukesh Thakur and the same is found fit and accepted by the Ld. Chief Judicial Magistrate, Calcutta.

Accused Mukesh Thakur is present before this Court by filing hazira.

In compliance with the condition imposed by the Hon'ble Court upon the Accused person, one petition is filed on behalf of the accused Mukesh Thakur stating his present residential address which is Raja Katra , 161, N.S Road, P.S. Burrabazar, Kolkata-70007, Mobile No. 89022103310. Let the same be kept with the Case record.

Accused Mukesh Thakur is hereby directed to comply the direction of the Hon'ble Court and furnish the address of his present residence and mobile number to I.O of this Case as well as the P.S concerned under whose jurisdiction he resides.

Now the Case record is taken up for hearing petition u/s. 294 Cr.P.C.

At this stage, petition u/s. 294 Cr.P.C filed on behalf of the prosecution is hereby rejected being not pressed by the Ld. P.P.

The Case is adjourned.

**Fix 22.07.2025 for appearance of all the accused persons and for evidence of CSW-2.**

All the accused persons on C.B. remain as as before with a direction to be present on the next date so fixed.

Issue summon accordingly.

Prosecution is hereby directed to bring the witness on the next date so fixed.
