Today is for production of the accused person Ajad Hussain @ Ahammed Hossain Azad @ Ajad Mallik and submission of I.O's report.

Accused Ajad Hussain @ Ahammed Hossain Azad @ Ajad Mallik is produced before this Court from J.C.

Ld. Advocate for the Enforcement Directorate as well as Ld. Advocate for the accused person are present.

The Investigating Officer of Enforcement Directorate files an application under section u/s 187 of the Bharatiya Nagarik Surksha Sanhita, 2023 and section 65 of the Prevention of Money Laundering Act, 2002 through Ld. Special Public Prosecutor for the Enforcement Directorate praying for further judicial custody of the accused person and also prays for interrogation of the accused in judicial custody and to record the statement of this accused u/s 50 of the PMLA, 2002.

Heard. Considered.

On careful perusal of the materials on record vis-a-vis the application u/s 187 of the Bharatiya Nagarik Surksha Sanhita, 2023 and section 65 of the Prevention of Money Laundering Act, 2002 it appears to me that judicial custody of the accused is essential to determine the role of various persons involved in the alleged offence who helps the accused illegally procuring Indian documents in lieu of money. It further appears that judicial custody is required to find out the role of money exchanger and Hawala operators. In view of above, detention of the accused in further judicial custody is essential for the sake of proper investigation. So, the prayer for further judicial custody of the accused person is **allowed**.

Ld. Special P.P of Enforcement Directorate prays for interrogation of this accused.

Ld. Advocate for the accused person raises no objection.

Heard. Considered.

The I.O is at liberty to interrogate and record the statement of the accused person Ajad Hussain @ Ahammed Hossain Azad @ Ajad Mallik with interrogation in the concerned correctional home in presence of Jail Superintendent but outside the scope and ambit of his hearing and after compliance of all the legal formalities with regard to interrogation inside the correctional home premises and the same is to be done after proper identification of the team of the Officers of Enforcement Directorate.

The Superintendent of Presidency Correctional Home is directed to render all cooperation after proper verification of the identity of the team of officers of the investigating agency.

Fixing **03.07.2025** for production of the accused person Ajad Hussain @ Ahammed Hossain Azad @ Ajad Mallik.

The accused persons be remanded to J.C till date i.e **03.07.2025**.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary compliance.

Let a copy of this order be also sent to the Investigating Officer through Ld. Special P.P of Enforcement Directorate for information.
