The accused person nos.1) Shri Tridip Pal @ Apu Da, 2) Md. Arman, 3) Shri Sanjib Dolui and 4) Shri Rakesh Mahato are found absent on calls.

Ld. Counsels for the above named four accused persons are present.

Three separate petitions along with Xerox copies of medical papers in respect of the accused person namely Tridip Pal @ Apu Da have been filed on behalf of the accused person nos.1) Shri Tridip Pal @ Apu Da, 2) Md.
