1. Today is fixed for hearing of the petition on the point of admission.
2. Ld. Advocate for the appellants is present by filing hazira.
3. It appears that the appellants have filed the instant memo of appeal challenging the judgement and order dated 30.10.2025 passed by the Ld. 6th Judicial Magistrate, Calcutta in connection with Complaint Case no. CS/32873 of 2019.
4. The memo of appeal is filed within the statutory period of limitation. So there is no legal bar or impediment to admit the instant appeal. Accordingly, the instant appeal is admitted **subject to the condition that the appellants shall deposit 20% of the compensation amount of Rs. 4,80,000/- before the Ld. Trial Court within 07.02.2026.**
5. Ld. Advocate for the appellants filed an application for staying the order of conviction dated 30.10.2025 passed by the Ld. Judicial Magistrate, 6th Court, Calcutta in connection with Complaint Case no. CS/32873 of 2019.

7. On careful perusal of the order and judgement dated 30.10.2025 passed by the Ld. Trial Court it appears to me that the appellant has an arguable case. Therefore, if the operation of the impugned order and judgement dated 30.10.2025 is not stayed, then the appellant will be highly prejudiced.
8. The prayer for staying the order of conviction dated 30.10.2025 passed by the Ld. Judicial Magistrate, 6th Court, Calcutta in connection with Complaint Case no. CS/32873 of 2019 is allowed for ends of justice.
9. The order of conviction dated 30.10.2025 passed by the Ld. Judicial Magistrate, 6th Court, Calcutta in connection with Complaint Case no. CS/32873 of 2019 is stayed till next date **(07.02.2026)**.
10. Issue notice upon respondent no.1/The State of West Bengal in usual manner and upon the respondent No.2 through court as well as registered post with A/D.
11. The appellants to file requisites at once.
12. Call for TCR.
13. Fixing **07.02.2026** for S.R, A.D and appearance and for filing receipt of showing deposit of 20% of the compensation amount before the Ld. Trial Court.
14. Let a copy of this order be sent to Ld. Trial Court for information.
