Sahabuddin, Firoja Begam, Shajahan Sk., Habibur Rahaman, Masadul Haque and Md. Tahabul Sk are found present in Court by filing hazira along with Ld. Advocates.

Two Vakalatnama have been filed on behalf of the all the above named 14 accused persons.

Let those be kept in the record.

On perusal of the L.C.R. this Court finds some other accused persons save and except the above named 14 accused persons, who have neither turned up, nor any step have been taken on behalf of those accused persons.

In view of the resolution **“not to pass any adverse order”** taken by local Bar, this Court is not inclined to pass any adverse order.

Accordingly, case is adjourned.

In view of the above, Ld. C.J.M, Murshdabad is directed to pass an order either directing the concerned Correctional Home authority/authorities to take necessary steps to produce the other accused persons, or directing the sureties to produce the accused persons save and except the above named accused persons before this Court on the next date fixed i.e.15.12.2022 at 10.30 a.m. if any.

One petition has been filed on behalf of the prosecution/NIA praying for time to file the final report in the interest of investigation.

Heard the Ld. Special P.P. of NIA.

Prayer is considered and allowed.

To **15.12.2022** for appearance of the accused persons, production of the accused persons by the sureties or from the J.C., if any, and submission of report in final form.
