The accused person namely Mansur Ali @ Manchhur Ali @ Mansur Sk. is produced before this Court from J.C.

Ld. Special P.P. of NIA and Ld. Advocate for the accused persons are present.

Today Santanu Pal, Insp./AIO, NIA, B.O., Kolkata has filed a petition through Ld. Special P.P. of NIA and prayed for further extending the judicial custody of the accused person namely Mansur Ali @ Manchhur Ali @ Mansur Sk. in the interest of further investigation.

Heard Ld. Special P.P. of NIA and Ld. Advocate for the accused person.

Considering the gravity and nature of the offence, prayer for remanding the accused person to J.C. is allowed to facilitate further investigation.

A Bail application has been filed on behalf of the accused namely Mansur Ali @ Manchhur Ali @ Mansur Sk.

Copy served.

Let the same be kept with the record.

Another petition has been filed on behalf of 3 (three) Accused persons namely Shajahan Sk., Habibur Rahaman and Masadul Haque stating that the Accused persons are the only earning members of their respective family and as such it is becoming very hard on part of the Accused/petitioners to appear before the Investigating Officer from Murhsidabad to Kolkata twice in every week and therefore it is prayed for waiving or modifying the condition regarding meeting the Investigating Officer twice in every week imposed upon the Accused at the time of granting Bail.

Ld. Special P.P. of NIA raises no objection and leaves it to the discretion of this Court.

Heard both sides.

Perused the case record wherefrom it reveals that the Accused namely Habibur Rahaman, Masadul Haque and Shajahan Sk. were granted Bail by the Ld. Sessions Judge, Mursidabad vide orders dated 29.04.2022 and 05.03.2022 respectively with condition to meet with the I.O. twice in a week until further order and/or till completion of investigation.

It also reveals from the order dated 28.03.2023 passed by this Court that this Court was pleased to waive condition in respect of the above named three accused persons for the time being to the extent that the Accused persons shall meet the Investigating Officer **once in a fortnight** instead of twice in a week until **28.04.2023**.

Considering the facts and conduct of the accused persons, prayer for waiving condition as imposed at the time of granting bail to the Accused persons namely Habibur Rahaman, Masadul Haque and Shajahan Sk. is allowed in part to the extent that the Accused persons shall meet the Investigating Officer **once in a week** instead of twice in a week until further order and rest of the portions of the orders or rest of the condition (s) will remain unaltered.

Fix **14.07.2023** for hearing of the bail application filed today on behalf of the on behalf of the accused namely Mansur Ali @ Manchhur Ali @ Mansur Sk.

Written objection, if any, in the meantime.

Fix **17.07.2023** for appearance of the Accused persons, production of the accused person namely Mansur Ali @ Manchhur Ali @ Mansur Sk. and submission of I.O's. report in final form.

The accused person namely Mansur Ali @ Manchhur Ali @ Mansur Sk. is remanded to J.C. till 17.07.2023.

The Accused persons on Bail are as before.

Later: order dated 03.07.2023
