To-day is fixed for production of the accused, **Mansur Ali @ Manchhur Ali @ Mansur Sk.**, for hearing of the petition dated 25.07.2023 filed on behalf of the Prosecution/NIA for invoking sections 16 & 18 of UA (P) Act in presence of both sides and submission of compliance regarding recording statement u/s 164 of Cr. P.C.

At this juncture, a petition has been filed on behalf of the accused person namely **Mansur Ali @ Manchhur Ali @ Mansur Sk.** praying for time to file written objection on the ground stated therein.

Heard both sides.

Prayer for time is considered and allowed for fair trial.
