Today I.O. has submitted charge sheet being CS no.30/23 dated 12.12.2023 against the 07 (Seven) Accused persons with a prayer to take cognizance.

Today B.D. Behera, Dy. S.P./C.I.O., NIA, B.O., Kolkata has filed a petition through Ld. Special P.P. of NIA with prayer to allow the NIA to file the Charge Sheet vide CS no.30/2023 dated 12.12.2023 against the accused persons namely (A-1) Imdadul Haque @ Imdarul Hoque @ Anaj Master, (A-2) Sukchand Ali @ Sukchand Sk., (A-3) Mansur Ali @ Mansur Seikh @ Mansur Sk. @ Manchur Ali, (A-4) Masadul Hoque @ Masadul Sk., (A-5) Habibur Rahaman @ Habu and (A-6) Md. Tahabul Sk. and (A-7) Iyasuddin Sk. with a further prayer to take cognizance of offence against the 07 (seven) Accused nos.(A-1 to A-7) as per the prayer made in the charge- sheet.

I.O. has also prayed for abating the charges against the accused no. (A-7) Iyasuddin Sk. as he succumbed to his injuries (Died in Blast).

I.O. has also prayed for allowing the NIA to continue investigation of the case u/s 173(8) Cr. P.C. against (A-8) to (A-17) accused persons, namely, Md. Sorabuddin Sk @ Surabuddin Sk, (A-8), Osman Sk @ Md. Osman Ali (A-9), Muklesur Rahaman @ Abir Hossain @ Muklesur Sk (A-10), Md. Sahabuddin Sk (A-11), Md Ashik Hossain @ Ashik Sk @ Ashik Hossain (A-12), Shajahan Sk @ Saju @ Sahajahan Sk (A-13), Toufikul Sk @ Akash (A-14), Sk Namdar Ali @ Namdar Ali (A-15), Firoja Begam @ Firoja Bibi (A-16) and Awlad Hossain (A-17) and their associates to further collect, identify and arrest other gang members involved in the conspiracy.

I.O. has also prayed in his petition that the relied upon materials objects/ articles / documents on the basis of which the charge sheet has been submitted be ordered to be retained by the NIA with a direction to produce the same before the court on the date fixed and as and when so directed.

Perused the case record and the documents relied upon by the prosecution including the Charge- Sheet.

It appears that prima facie Prosecution has been able to make out a case against the 07 Accused (A-1) Imdadul Haque @ Imdarul Hoque @ Anaj Master, (A-2) Sukchand Ali @ Sukchand Sk., (A-3) Mansur Ali @ Mansur Seikh @ Mansur Sk. @ Manchur Ali, (A-4) Masadul Hoque @ Masadul Sk., (A-5) Habibur Rahaman @ Habu and (A-6) Md. Tahabul Sk. and (A-7) Iyasuddin Sk.

Thus, cognizance of offence is taken.

Heard the Ld. Special P.P. of NIA regarding prayers of I.O. Considered.

The accused no.(A-7) **Iyasuddin Sk.** be abated as he succumbed to his injuries as per prayer made in the charge on behalf of the Prosecution.

The documents / materials/ articles as per list in the charge sheet kept in trunk under lock and key be handed over to the NIA for safe custody with a direction to produce the same before the court as and when called for. The keys of the trunks containing documents/ materials/ articles shall be kept in the safe custody of the court.

Prayer of the I.O. regarding continuation of further investigation of the case u/s 173(8) Cr.P.C. against (A-8) to (A-17) accused persons namely, **Md. Sorabuddin Sk @ Surabuddin Sk, (A-8), Osman Sk @ Md. Osman Ali (A-9), Muklesur Rahaman @ Abir Hossain @ Muklesur Sk (A-10), Md. Sahabuddin Sk (A-11), Md Ashik Hossain @ Ashik Sk @ Ashik Hossain (A-12), Shajahan Sk @ Saju @ Sahajahan Sk (A-13), Toufikul Sk @ Akash (A-14),**

**Sk Namdar Ali @ Namdar Ali (A-15), Firoja Begam @ Firoja Bibi (A-16) and Awlad Hossain (A-17)** and their associates is considered and allowed for the interest of investigation supplementing to it.
