By filing a separate petition along with a CIS copy of order dated 23.02.2024 passed by the Hon'ble High Court at Calcutta in connection with C.R.A. (DB) 15 of 2024, Ld. Counsel for the accused person namely Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. submits that charge sheet has already been submitted against the accused/petitioner, but no copies of charge sheet along with other documents have yet been supplied to the accused/petitioner.

Ld. Counsel for the accused person further submits that the accused/petitioner has preferred a bail application before the Hon'ble High Court at Calcutta and the copies of charge sheet and all relied upon and non relied upon documents are very much required for the purpose of moving the matter before the Hon'ble Court and therefore it is prayed for a direction upon the Prosecution/NIA to supply copies of the charge sheet and all relied upon and non relied upon documents along with the index to the accused/petitioner as per the section 207 of Cr. P.C.

Heard the Ld. Counsel for the accused person.

Perused the CIS copy of order dated 23.02.2024 wherein the Hon'ble High Court at Calcutta has been pleased to observe as follows:

*“Mr. Mukherjee, learned Senior Counsel for the appellant submits he would make submission after pursuing the papers supplied to him under section 207 Cr. P.C.*

*He prays for accommodation for three weeks.*

*Matter will appear three weeks hence (15.03.2024).”*

On perusal of the case record, it is explicit that charge sheet was submitted against 7 (seven) accused persons including the above mentioned accused person on 12.12.2023 and next date has been fixed on 07.03.2024 for hearing the petitions dated 20.02.2024 and date for production of the above named accused person has been fixed on 19.03.2024.

Considering the order dated 23.02.2024 passed by the Hon'ble High Court at Calcutta in connection with C.R.A. (DB) 15 of 2024, Prosecution/NIA is directed to supply copies of the charge sheet and all relied upon and non relied upon documents along with the index to the accused/petitioner as per the section 207 of Cr. P.C. read with section 91 Cr. P.C. on 07.03.2024 with a further direction to file an acknowledgment receipt in this regard.

To-date i.e. **07.03.2024** for production of the accused person namely Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. and supply of copy.

The Superintendent of Presidency Correctional Home is directed to take necessary steps to ensure production of the accused person namely Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. before this Court on 07.03.2024.

To-date i.e. on **07.03.2024** for hearing of the two petitions dated 20.02.2024 filed on behalf of the accused persons namely Habibur Rahaman, Masadul Haque, Shajahan Sk., Md. Ashik Hossain, Md. Surabuddin Sk. and Md. Osman Ali praying for waiving or modifying the condition of bail.

To-date i.e. on **19.03.2024** for appearance of the accused persons, production of the accused person namely Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. and further hearing of the petition u/s 439(2) Cr. P.C dated 18.07.2023 for cancellation of bail against accused persons namely, Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk.

Let a copy of this order be forwarded to the I.O of this case through Ld. Special P.P. for information and necessary compliance.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary action.
