Fix **24.07.2024** for appearance of the accused persons, production of the accused person namely Mansur Ali @ Mansur Sheikh @ Manchur Ali @ Mansur Sk., submission of report with regard to the conduct of the accused persons who are on Court bail and further hearing of the petition u/s 439(2) Cr. P.C dated 18.07.2023 for cancellation of bail against accused persons namely, Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk.
