On submission of both side fix. **12.09.2024** for appearance of all the accused persons, production of the accused person namely Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk., further hearing of the petition u/s 439(2) Cr. P.C dated 18.07.2023 for cancellation of bail against accused persons namely, Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk.

To date i.e. on 12.09.2024 is also for hearing of the petition filed today by the Ld. defense counsel on behalf of the accused person namely, Shajahan Sk. praying for waving or modifying the condition imposed upon the accused person to meet the I.O.once in a week.
