Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk filed on 22.08.2024 on behalf of the Prosecution/NIA.

The accused persons namely Toufikul Sk., Md. Tahabul Sk., Abir Hossain and Masadul Sk. are found absent on calls.

Ld. Special P.P., NIA is present.

Ld. Advocates for the accused persons are present.

The accused person is identified by the concerned Jail Authority and he expressed before this Court that he could see and hear the entire court proceedings without any technical glitch.

Tahabul Sk. together with compliance report with regard to the criminal antecedents and conduct of the four accused persons namely Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk filed on 22.08.2024 on behalf of the Prosecution/NIA from the side of the Ld. Defense Counsel is taken up for further hearing.
