Today is fixed for production of the accused persons namely Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk. and Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. before this Court from J.C. and appearance of rest of the accused persons.

The accused persons namely, Md. Sahabuddin, Sk. Namadar Ali, Md. Ashik Hossain, Md. Sorabuddin Sk., Firoja Begam, Toufikul Sk., Abir Hossain and Habibur Rahaman are present in Court by filing haziras.

The accused persons namely Md. Osman Ali and Shajahan Sk. are found absent on calls.

Ld. Special P.P. for NIA is present.

Ld. Advocates for the accused persons are present.

A petition has been filed on behalf of the accused persons namely Md. Osman Ali and Shajahan Sk. stating that the above named accused person are unable to attend Court today and therefore the Ld. Counsel prays for condoning their absence with a further prayer for representation of these accused persons through their Ld. Counsel u/s 317 of Cr. P.C.

Heard both sides on the point of condoning their absence and also on the point of representation of the accused persons through their Ld. Counsel u/s 317 of Cr. P.C.

Prayer for representation of the accused persons namely Md. Osman Ali and Shajahan Sk. through their Ld. Counsel u/s 317 of Cr. P.C. is considered and allowed with a direction upon all these accused persons to remain present before this Court on the next date fixed positively i.d. necessary order will be passed in accordance with law.

Ld. Counsel for the accused persons namely Md. Osman Ali and Shajahan Sk. is at liberty to represent those accused persons u/s 317 of Cr. P.C.

The accused persons namely Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk. and Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. have been produced from J.C. in virtual mode.

The accused persons are identified by the concerned Jail Authority and they expressed before this Court that they could see and hear the entire court proceedings without any technical glitch.

Ld. Special P.P. for NIA files a server copy of order dated 17.03.2025 passed by the Hon'ble High Court at Calcutta in connection with C.R.A. (DB) 15 of 2024 and submits that Hon'ble Court directed the investigating agency to take expeditious steps for the purpose of framing the charges as against the accused persons and therefore the Ld. Special P.P. prays for fixing a date for consideration of charge.

Perused the server copy of order dated 17.03.2025 in C.R.A. (DB) 15 of 2024 wherein the Hon'ble Court has been pleased to observe inter alia as follows:

“There are materials requiring the petitioner to stand trial for the charges leveled in the charge sheet against him.

Charges are yet to be framed. No doubt, expeditious steps would be taken by the investigating agency for the purpose of framing the charges as against the petitioner.

Period of detention is not such that at this stage, we should be required to invoke Article 21 of the Constitution of India in favour of the petitioner.

The incident is serious in nature with a person succumbing to bomb blast injuries and several others suffering injuries. Petitioner is alleged to be involved in the fabrication of such bombs when the blast took place.

Considering the gravity of the offence and the involvement of the petitioner in the incident, we are not inclined to grant bail to the petitioner.

This application for bail is, thus, rejected.”

Let the server copy of the solemn order dated 17.03.2025 passed by the Hon'ble High Court at Calcutta in connection with C.R.A. (DB) 15 of 2024 be kept with the record.

Heard both sides.

On submissions of both sides and also keeping in mind the direction of the Hon'ble Court in C.R.A. (DB) 15 of 2024 upon the investigating agency to take expeditious steps for the purpose of framing the charges as against the petitioner/accused person, fix **23.04.2025** for production of the accused persons namely Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk. and Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. before this Court from J.C., appearance of the rest of the accused persons and hearing on the point of consideration of charge.

The accused persons namely Md. Imdadul Hoque @ Anaj Master @ Imdadul Hoque, Masadul Sk., Sukchand Ali @ Sk. and Md. Tahabul Sk. and Mansur Ali @ Mansur Seikh @ Manchur Ali @ Mansur Sk. are remanded to J.C. till date.

The accused persons on Court bail are as before.

All the accused persons on Court bail are directed to remain present before this Court on the next date fixed positively.

Let a copy of this order be forwarded to the I.O of this case through Ld. Special P.P. with a direction to ensure production of the C.D. on the date fixed.
