Order No. 73 dated 27.06.2025

Today is fixed for production and appearance of the accused persons and hearing on the point of consideration of charge.

The accused persons namely **(A-1) Md. Imdadul Hoque @ Imdarul Hoque @ Anaj Master, (A-2) Sukchand Ali @ Sukchand Sk, (A-3) Mansur Ali @ Mansur Sheikh @ Mansur Sk. @ Manchhur Ali, (A-4) Masadul Sk @ Masadul Haque** and **(A-6) Md. Tahabul Sk.** are produced before this Court in physical mode.

The accused persons namely, Md. Sahabuddin, Sk. Namadar Ali, Md. Ashik Hossain, Md. Sorabuddin Sk., Firoja Begam, Toufikul Sk., Md. Osman Ali, Shajahan Sk., Abir Hossain and Habibur Rahaman are present in Court by filing hazira.

Ld. Counsels for the accused persons and the Ld. Special P.P. for NIA are present.

Ld. Counsel for the accused persons namely Md. Imdadul Hoque @ Imdarul Hoque @ Anaj Master and others has filed a petition u/s 227/228 of the Cr. P.C. praying for discharging the accused/petitioners on the ground stated therein.

The petition dated 27.06.2025 u/s 227/228 of the Cr. P.C. is, thus, disposed of.

Counsels for the accused persons have filed another petition praying for a direction upon the Prosecution/NIA to remove the section 18 of the Unlawful Activities (Prevention) Act, 1967 from the charge sheet bearing no.30 of 2023 dated 12.12.2023 filed by the Prosecution/NIA on the ground stated therein.
