Today is fixed for hearing of the petitions dated 11.08.2025 filed on behalf of the accused persons namely Habibur Rahaman @ Habu and Md. Sorabuddin Sk @ Surabuddin Sk, Md. Osman Ali @ Osman Sk., Md. Ashik Hossain @ Ashik Sk @ Ashik Hossain and Shajahan Sk. @ Saju @ Sahajahan Sk praying for waiving the conditions of bail.

Ld. Advocate for the accused persons as well as the Ld. Public Prosecutor for NIA are present.

Now the record is taken up for hearing.

Ld. Advocate for the accused Habibur Rahaman @ Habu submits that this accused has complied with all the conditions of bail till today and there is no adverse report against him. He further submits that after completion of investigation charge sheet has already been submitted in this case. So, further meeting with the I.O is not necessary and he prays for waiving the condition to meet with the I.O further.

Ld. Special Public Prosecutor raises objection.

Heard both sides. Perused the petition and the materials available in the case record.

It appears from the record that this accused person is a prime accused and all the allegations against him. It further appears from the record that charges have already been framed against this accused person and the record is ready for trial.

Considering the facts and circumstances of the case, I am inclined to modify the condition of meeting with the Investigating Officer of NIA once in a fortnight instead of meeting with the Investigating Officer NIA twice in a week.

Ld. Advocate for the accused persons Md. Sorabuddin Sk @ Surabuddin Sk, Md. Osman Ali @ Osman Sk., Md. Ashik Hossain @ Ashik Sk @ Ashik Hossain and Shajahan Sk. @ Saju @ Sahajahan Sk submits that these accused have complied with all the conditions of bail till today and there is no adverse report against them. He further submits that after completion of investigation charge sheet has already been submitted in this case. So, further meeting with the I.O is not necessary and he prays for waiving the condition to meet with the I.O further.

Ld. Special Public Prosecutor raises no objection.

Heard both sides. Perused the petition and the materials available in the case record.

It appears from the record that charges have already been framed against this accused persons and the record is ready for trial and there is no adverse report against the accused persons.

Considering the above facts and circumstances of the case, I am inclined to allow the prayer of the above named accused persons and the accused persons accused persons Md. Sorabuddin Sk @ Surabuddin Sk, Md. Osman Ali @ Osman Sk., Md. Ashik Hossain @ Ashik Sk @ Ashik Hossain and Shajahan Sk. @ Saju @ Sahajahan Sk is not required to meet the I.O henceforth.

Both the petitions dated 11.08.2025 are disposed of.

The other conditions of bail remains unaltered.
