1. Today is fixed for production & appearance of the accused persons, recording evidence of CSW-1 and hearing of the petition dated 19.01.2026 filed on behalf of the accused Habibur Rahaman and written objection, if any, in the meantime.
2. The accused person, namely, Mansur Ali @ Mansur Seikh @ Mansur Sk. @ Manchhur Ali, is produced before this Court from J.C. through audio video electronic means
3. The accused persons, namely, Sukchand Ali @ Sukchand Sk, Masadul Sk @ Masadul Haque, Md. Tahabul Sk., Md. Imdadul Hoque @ Imdarul Hoque @ Anaj Master and Habibur Rahaman @ Habu, on Court bail, are present by filing hazira.
4. Ld. Special Public Prosecutor for NIA for the State is present.
5. Ld. Advocates for the accused is present today.
6. CSW-1 Sanjib Karmakar is present before this Court.
7. Now, the record is taken up for recording evidence.
8. CSW-1 Sanjib Karmakar is examined in chief as PW-1 by the Ld. Special Public Prosecutor in part.
9. Examination in chief of PW-1 is deferred on prayer of the Ld. Special Public Prosecutor.
10. During the course of examination, the seizure list dated 17.01.2022 is marked as Exhibit P-1/PW-1 (on proof), the complaint is marked as Exhibit P-2/PW-1 (on proof) and the signature of PW-1 on the formal FIR is marked as Exhibit P-3/1/PW-1.
11. As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of PW-1 dated 12.02.2026 is handed over to all sides after obtaining endorsement in the relevant register.
12. Reissue summons accordingly.
13. Written objection against the petition dated 19.01.2026 filed on behalf of the accused Habibur Rahaman has been filed by the Ld. Special Public Prosecutor representing the NIA. Perused the same and let it be kept with the record.
14. Fix **05.03.2026** for production & appearance of the accused persons, further examination in chief of PW-1 and hearing of the petition dated 19.01.2026 filed on behalf of the accused Habibur Rahaman.
15. Accused Mansur Ali @ Mansur Seikh @ Mansur Sk. @ Manchhur Ali be remanded to J/C till 05.03.2026.
16. Accused persons, namely, Sukchand Ali @ Sukchand Sk, Masadul Sk @ Masadul Haque, Md. Tahabul Sk., Md. Imdadul Hoque @ Imdarul Hoque @ Anaj Master and Habibur Rahaman @ Habu , on bail, are as before.
