2. Today is fixed for production and appearance of the accused persons, further examination in chief of P.W.1 and hearing of the petition dated 19.01.2026 filed on behalf of the accused Habibur Rahaman.
3. The accused persons namely **Mansur Ali @ Mansur Seikh @ Mansur Sk. @ Manchhur Ali** is produced before this Court from J.C. through audio video electronic means.
4. The accused persons namely Sukchand Ali @ Sukchand Sk, Masadul Sk @ Masadul Haque, Md. Tahabul Sk., Md. Imdadul Hoque @ Imdarul Hoque @ Anaj Master and Habibur Rahaman @ Habu on Court bail are present by filing hazira.
5. Ld. Counsels for the accused persons are present.
6. Ld. Special P.P. for NIA is present.
7. No witness has turned up today.
8. A petition has been filed on behalf of the Prosecution/NIA stating that the C.S.W.1 namely **Sanjib Karmakar** is unable to attend Court today and therefore an adjournment has been prayed for.
9. Heard both sides.
10. Prayer for an adjournment is considered and allowed with a direction upon the Prosecution/NIA to take necessary steps to ensure attendance of the witness on the next date fixed positively.
11. A petition has been filed on behalf of the accused person namely Md. Imdadul Hoque praying for alteration of charge head of the Unlawful Activities (Prevention) Act under section 16 of the Code of Criminal Procedure, 1973 on the ground stated therein.
