Order no. 23 dated 28.06.2023

To-day is fixed for production of all the three accused persons before this Court from J.C. and hearing of the bail application dated 14.06.2023 filed on behalf of the Accused no.(A-2) Sayeed Ahmed.

The Accused persons namely,

- 1) Md. Saddam @ Saddam Mallick @ Abdul Mallick,
- 2) Sayeed Ahmed and
- 3) Abdul Raqib Qureshi

are produced from J.C.

Ld. Advocate for the Accused persons and Ld. Special P.P. of NIA are present.

Insp./CIO, NIA, B.O., Kolkata has filed a petition through Ld. Special P.P. of NIA stating that further investigation is at nascent stage and crucial number of oral/documentary evidence is yet to be collected and extension of judicial custody of all the three accused persons is absolutely necessary to identify, intercept and arrest of the other co-accused scattered through India and so it is prayed for extension of J.C. of all the three accused persons in the interest of investigation.

The bail application dated 14.06.2023 filed on behalf of the Accused no.(A-2) Sayeed Ahmed is taken up for hearing.

At this stage, Ld. Advocate for the Accused no.(A-2) Sayeed Ahmed submits before this Court that he intends to not press the bail application dated 14.06.2023 and subsequently, Ld. Advocate for the Accused no.(A-2) puts an endorsement on the bail application dated 14.06.2023 with remark "not pressed."

Accordingly, the bail application dated 14.06.2023 filed on behalf of the Accused no.(A-2) Sayeed Ahmed stands rejected being not pressed.

Thus, the bail application dated 14.06.2023 is disposed.

The petition praying for further J.C. of the three accused persons is taken up for hearing.

Heard Ld. Special P.P. and Ld. Advocates for the accused persons.

Considering the gravity and nature of the case, prayer for extension of J.C. of all the three Accused persons is considered and allowed to facilitate further investigation.

A bail application has been filed on behalf of the on behalf of the Accused nos.(A-1) Md. Saddam @ Saddam Mallick @ Abdul Mallick and (A-3) namely Abdul Raqib Qureshi.

Another petition has been filed on behalf of the Accused nos.(A-1) Md. Saddam @ Saddam Mallick @ Abdul Mallick and (A-3) namely Abdul Raqib Qureshi stating that tomorrow i.e.29.06.2023 is Eid-ul-Zoha and prayed for a direction upon the Superintendent of Presidency Correctional Home for providing plastic table cloth and Zanawaz (mat) to the above named accused persons for performing Namaz on the holy occasion.

Received one medical report in respect of the accused person namely (A-1) Md. Saddam @ Saddam Mallick @ Abdul Mallick along with one forwarding letter from the Superintendent of Presidency Correctional Home vide office letter no.8027/IMB dated 27.06.2023.

Perused the same and let the same be kept with the record.

The Superintendent of Presidency Correctional Home is directed to continue to provide proper medical treatment and medicine to the above named accused person as per prescription of the Medical Practitioner.

Fix **04.07.2023** for hearing of the bail application filed today on behalf of the Accused nos.(A-1) Md. Saddam @ Saddam Mallick @ Abdul Mallick and (A-3) namely Abdul Raqib Qureshi.

Written objection, if any, in the meantime.

Fix **12.07.2023** for production of all the three accused persons before this Court from J.C. and further order.

The accused persons are remanded to J.C. till 12.07.2023.

Let a copy of this order be sent to the Prosecution/NIA through Ld. Special P.P. of NIA with a direction to ensure production of the C.D. on the next date i.e.04.07.2023.
