Order No.06 dated 27.03.2023

Today is fixed for production of all the accused persons and hearing of the bail applications dated 13.03.2023 filed by all three the accused persons.

All the three accused persons are produced from J.C before this Court.

Ld. Spl. P.P of NIA is present with I.O along with C.D.

Ld. Advocates on behalf of the accused persons are present.

Ld. Spl. P.P of NIA files petitions praying for 14 days judicial custody of all the accused persons and files another petition praying for collecting Finger prints of all the accused persons in the Presidency Correctional Home and also filed three written objection regarding the bail prayer of the accused persons.

The bail applications dated 13.03.2023 in respect of all the three the accused persons namely,

1) Md. Saddam @ Saddam Mallick @ Abdul Mallick,

2) Sayeed Ahmed and

3) Abdul Raqib Qureshi

are taken up for hearing.

Heard Ld. Spl. P.P of NIA as well as Ld. Advocates for two sets of accused persons who prayed for bail.

Perused the C.D and the Materials on Record. Ld. Advocates for the Defence submitted that only the mobile is seized and nothing more was seized from the custody of these accused persons. Mobile Phone and Pen Drive have also been recovered from their possession.

On careful perusal of the Case Diary it appears that there is a larger criminal conspiracy for waging war against the Government by means of a terrorist attack and there is involvement of those accused persons in recruiting Muslim youths for terrorist activities. The CDR is still being scrutinized by the Delhi Team of NIA. The nature of the case is very serious and there is every possibility of getting more materials during the process of investigation.

Considering all the aspects of the matter, the bail petitions for these accused persons are rejected.

Accused persons are remanded to J.C till 10.04.2023.

The praying of the Ld. Spl. P.P of NIA for collecting Finger prints of the accused persons are allowed with a direction to the Superintendent of Presidency Correctional Home to allow CIO, Shri Soumen Biswas along with his team to collect the finger print of all the above mentioned three accused persons in presence of Ld. MM, Calcutta, so nominated by Ld. CMM, Calcutta.

Fix 10.04.2023 for production of all the accused persons.
