On submission of both sides, fix **17.03.2025** for production of both the Accused persons from the J.C. before this Court and further cross-examination of P.W.-17, Susanta Dhar.

Re-issue the Summon in the name of P.W.-17, Susanta Dhar with a direction to remain present before this Court on the next date fixed for adducing further evidence.

Both the Accused persons are remanded to J.C. till 14.02.2025.
