ORDER

1. Read application moved by the accused/applicant. By virtue of present application accused prayed to release him on provisional cash bail.

2. Ld. APP objected the application and file say on overleaf. It is contended that if he released on bail, he will abscond. On above

ground she prayed to reject the application.

3. Perused record. It appears that bail has been granted to the accused subject to certain condition vide order dated 25.04.2025. The accused has not furnish the bail as he is unable to furnish surety till this date due to some reason. As bail is already granted to the accused no purpose would serve, by keeping him behind jail furthermore. In the circumstances, on certain condition I am allowing the application, hence, the order :

: ORDER :

1. Application (Exh.8) for provisional cash bail is allowed.
2. Accused/applicant **Mahesh Satay Yadav**, is allowed to deposit cash of Rs.25,000/- (Rupees Twenty Five Thousand Only) in C.R. No.565 of 2024 registered at **Andheri** Police Station for offence punishable under Section 118(1), 115(2), 352, 74 of BNS r/w. Section 7, 8 of the POCSO Act.
3. Accused shall furnish surety on or before 16.06.2025 without fail.
4. Rest of the conditions of bail order dated 25.04.2025 is kept as it is.
5. Application (Exh.8) stands disposed of accordingly.
