

Order No.-105

The record is put up today on the basis of put up petition filed on behalf of the accused Rajkumar Singh @ Raju alongwith a petition praying for furnishing the bail bond in respect of the accused and a certified to be a true copy of order of the Hon'ble High Court, Calcutta, passed in CRM(DB) No.- 4079 of 2023 dated 28/11/2023.

A fresh power is also filed separately on behalf of the accused. Let those be kept with the record.

It is submitted that the Hon'ble High Court, Calcutta in CRM(DB) No.- 4079 of 2023 dated 28/11/2023 has been pleased to grant bail petition on condition to the accused and directed the accused/ petitioner to furnish a bond of Rs.10,000/- with two sureties, one of whom must be local. It is further submitted that the accused/ petitioner intends to furnish the bail bond today.

I find that the Hon'ble High Court, Calcutta in CRM(DB) No.- 4079 of 2023 dated 28/11/2023 has been pleased to grant bail to the accused/ petitioner with direction that the petitioner shall be released on bail upon furnishing a bond of Rs. 10,000/- with two sureties of like amount each, one of whom must be local, to the satisfaction of this Court, subject to conditions that the petitioner shall appear before the trial court on every date of hearing until further orders and shall not intimidate the witnesses and/ or tamper with evidence in any manner whatsoever. In the event the petitioner fails to appear before the trial court without justifiable cause, the trial court shall be at liberty to cancel his bail in accordance with law without further reference to the Hon'ble Court.

In view of above, I direct Rajkumar Singh @ Raju to furnish a bond of Rs. 10,000/- with two sureties of like amount each, one of whom must be local, subject to conditions that:

- 1) the accused/ petitioner shall appear before this Court on every date of hearing until further orders;
- 2) the accused/ petitioner shall not intimidate the witnesses and/ or tamper with evidence in any manner whatsoever;
- 3) in the event the accused/ petitioner fails to appear before this Court without justifiable cause, the Court shall be at liberty to cancel his bail in accordance with law without further reference to the Hon'ble Court.

The office of Ld. CMM, Calcutta do arrange to fit the bail bonds of the registered sureties.

Let a copy of this order be sent to the Ld. CMM, Calcutta for necessary action.

Let another copy of this order be sent to the I.O of this case for information.

Let the softcopy of this bail order be sent to the Superintendent, Presidency Correctional Home, Calcutta by email.
