CHARGE

I, **D. G. Dhoble**, Additional Sessions Judge, Sessions Court, Dindoshi (Borivali Division), Goregaon(E), Mumbai, hereby charge you :

as follows

FIRSTLY, that you accused on 26/01/2021 at 03.30 hrs, from Room No.101, Shree Bramhrshi Society, in front of Nirankari Bhavan, Ambojwadi, Gate No.08, Malvani, Malad (West), Mumbai took and enticed and thereby kidnapped a victim a minor girl aged about 15 years and 05 months out of keeping of the lawful guardianship of minor without consent of informant who was lawfully entrusted with care or custody of victim and you thereby committed an offense punishable under **Section 363 of Indian Penal Code** and within my cognizance.

SECONDLY, that you accused during period 26/01/2021 and

date of arrest repeatedly committed rape upon minor victim by engaging in non-consensual sexual intercourse with her under the pretext of marriage and thereby committed an offense punishable under **Section 376(2)(n)** of Indian Penal Code and within my cognizance.

THIRDLY, you accused during aforesaid period committed repeatedly penetrative sexual assault on the minor victim girl aged about 15 years and 05 months and thereby committed an offence punishable **under Section 6 of Protection of Children from Sexual Offences Act, 2012** and within my cognizance.

FOURTHLY, you accused during aforesaid period committed sexual harassment upon the victim girl and thereby committed an offence punishable **under Section 12 of Protection of Children from Sexual Offences Act, 2012** and within my cognizance.

LASTLY, you accused during aforesaid period induced minor girl to go through a form of marriage with you, knowing that she was under age as defined under the prohibition of Child Marriage Act, 2006 and thereby committed an offence punishable **under Section 9 of the said act**.

And I hereby direct that you be tried for above all said offences.
