The Supplementary case record is opened today as one petition has been filed by the accused/ petitioner namely **Sourabh Agarwal along with** of one **certified** copy of the order dated 08-10-2024 ,passed by Hon'ble Court in one criminal revisional case revisional Case No. CRM (DB) 3190of 2024 in connection with this instant case, on perusal of which it appears that Hon'ble Court has been pleased to released on interim bail to the accused/ petitioner namely **Sourabh Agarwal** upon furnishing bond of Rs. 10,000/- with two surety of Rs. 10,000/- each , one of whom must be local , subject to the satisfaction of this Court and on condition to remain present before the Court of Id. One petition has been filed today by the local surety namely **Abdus Salim fouzder** along with Xerox copy of Aadhaar card being No. 2957 4762 2826 duly identified by Id. lawyer with a prayer for permission to stand as local surety for the accused/petitioner **Maya Halder**. The prayer is considered and allowed.

One bail bond of Rs. 10,000/- furnished by the registered surety namely Sudha Shankar Shaw as well as other one of the equivalent amount has been furnished by the local surety namely , **Abdus Salim fouzder** ,s/o:- Late Harun Rashid Fouzder, r/o:- 17/2H/2 , Smith Lane , PS Taltala, Kolkata-700013 by putting in one Savings Bank Pass Book under NSC VIII Scheme issued by **Council House Street** sub PO, being Account No. **020010329585** dated **12-04-2021** , **valid till 12-04-2026** of Rs. **10,000/-** in the name of **Abdus Salim Fouzder** for the accused/petitioner namely **Sourabh Agarwal** that are found fit and accepted. Issue R/O, if any.

The Original one Savings Bank Pass Book under NSC Scheme issued by **Council House Street**, Account No. **020010329585** dated **12-04-2021** , **valid till 12-04-2026** of Rs. **10,000/-** in the name of **Abdus Salim Fouzder** for the accused/petitioner namely **Sourabh Agarwal** be send and kept under the secured custody of the Sherestader Grade-II of this Court until Further Order.

Let a Letter of Intimation be given to the Post Master , **Council House Street** Post Office , Kolkata not to allow the encashment of / Closure / premature withdrawal of / from Account No. **020010329585** dated **12-04-2021** , **valid till 12-04-2026** of Rs. **10,000/-** in the name of **Abdus Salim Fouzder** for the accused/petitioner namely **Sourabh Agarwal** until receipt of any further order of this Court or any Id. Higher Court.
