He is taken into custody.</p> <p>Ld. Defence Counsel appearing on behalf of the accused person files and moves a petition (I.A-01/2024) and submits that the accused person in connection with this case has preferred an application u/s 438 of the Code of Criminal Procedure, 1973 before the Ld. Sessions Judge, South 24-Parganas, Alipore.</p> <p>Ld. Defence Counsel further submits that Ld. Sessions Judge, South 24-Parganas, Alipore in the said application being Criminal Misc Case No. 4516/2019 has been pleased to grant anticipatory bail to the present accused person. Accordingly, Ld. Defence Counsel prays for bail on behalf of the said accused person. Ld. Defence Counsel files certified copy of the said order. Seen and kept with the record.</p> <p>Ld. Assistant Public Prosecutor raises formal objection.</p> <p>Heard the submission of Ld. Counsel for both the sides and considered the same. Perused the materials on record.</p> <p>On perusal of the order sheet of Ld. Sessions Judge, South 24-Parganas, Alipore in Criminal Misc Case No. 4516/2019 dated 01.08.2019 it transpires that the present accused person has been released on bail. That being the case, the prayer of the accused person is considered and allowed.</p> <p>The accused is released on bail upon furnishing bail bond of ₹ 5,000/- with two registered sureties of ₹ 2,500/- each in default to Judicial Custody.</p> <p>At this juncture Ld. Defence Counsel prays for supply of the copy which according to him is with the case record and has not been received by him.</p> <p>On perusal of the case record admittedly, it transpires that copy of the charge sheet as well as allied documents u/s 173(5) of Code of Criminal Procedure, 1973 is appended with record.
