ORDER

- 1) Vide this order, I shall dispose of the regular bail application filed by the accused/ applicant in the above mentioned case.
- 2) Record received. Heard. It is mentioned in the bail application that the accused/ applicant is in custody since 16.7.2025 and no more required for any other purpose. It is further averred that nothing is to be recovered from the accused/ applicant and all the necessary recovery as alleged by the police has already been effected from the person of accused/ applicant. It is further averred that conclusion of trial is likely to take a considerable time, so no useful purpose shall be served by keeping the accused behind bars for an indefinite period. Hence the bail application.
- 3) Ld.counsel for the accused/ applicant while arguing in the lines of his bail application, contended that bail application may be allowed. Ld. Counsel for accused/ applicant also placed reliance on

judgments cited as **Ranjan Kumar alias Chhotu vs. State of Punjab (Punjab and Haryana) Law Finder Doc Id # 2699624**, **Kanwaljit Singh alias Gora versus State of Punjab, CRM-M-8844 of 2025**, decided on 21.02.2025, **Re-Inhuman Conditions in 1382 Prisons, 2017(4) RCR (Criminal) 416** and **Dataram Singh v. State of Uttar Pradesh (SC) Law Finder Doc Id # 970724 / 2018(2) RCR (Criminal) SC**

4) Conversely, learned Addl. Public Prosecutor for the State submitted that there are serious allegations against the accused/ applicant and bail application may be dismissed.

5) After hearing rival submissions, it has transpired that instant case was registered on the allegations that on 8.7.2025, accused persons in furtherance of criminal conspiracy of each other committed murder of Gursewak Singh and instant case was registered on the statement of Tarsem Singh. During investigation of the case, accused/ applicant was apprehended and after completion of investigation, challan was presented.

6) Having regard to serious allegations against accused/ applicant regarding murder of Gursewak Singh, no ground is made out to extend the benefit of regular bail to the applicant/ accused. Resultantly, instant bail application is dismissed. File be attached with the main file.
