Today is fixed for report on completion of investigation.

The FIR named accused persons on court bail are absent by filing a petition praying for another date as they could not turn up before the Court due to illness.

Heard. Considered. Prayer is allowed.

No report on completion of investigation is received from the Officer-in-Charge, Narkeldanga PS.

However, the Officer-in-Charge, Narkeldanga PS submitted one application stating that as per the available PS records such as crime index etc., the instant case was registered and investigated by S.I Samit Kumar Bera under the supervision of Sri Saran Lama, the then Additional Officer-in-Charge, Narkeldanga P.S and Sri Sudipta Nag, the then Assistant Commissioner (I), ESD and after completion of investigation the case was declared for charge sheet and accordingly the I.O of the instant case S.I Samit Kumar Bera prepared charge-sheet vide C/S no.-53 of 2018 dated 28.04.2018 but the same has not been submitted before the Court. He further stated in his report that presently S.I Samit Kumar Bera is posted at jadavpur P.S, South Suburban Division and the case diary along with copy of the prepared charge-sheet is lying with him. He further stated in his report that the Deputy Commissioner of Police, Eastern Suburban Division has been pleased to direct the S.I Samit Kumar Bera to continue with the investigation into the instant case as further investigation into the instant case is required and the same is on progress.

However, the Officer-in-Charge, Jadavpur P.S also forwarded one application submitted by the Investigating Officer stating that the case is being re-investigated by him under order of superiors. More over Water Supply Department, KMC and other departments were already sent but some of the reports are still awaiting. He further stated in his report that he has been selected as election nodal officer of Jadavpur P.S in connection with the upcoming assembly election, 2021, for which he has to remain engaged excessively at outdoor events and also in election related matters most of the time as per the direction of Election Commission of India and as such he has prayed for another date / some time for submitting the final report.

Heard.

The Ld. APP has stated that considering the ground the prayer may be allowed.

Considering the ground and submission of the Ld. APP the prayer is allowed.

The Investigating Officer is directed to complete the investigation without unnecessary delay.

The Officer-in-Charge of the concerned PS is directed to forward the report as soon as the investigation is completed by the Investigating Officer.
